Annual General Meeting of Northern Districts Social Car Club

1. Tenure of Office.

"No member of the executive committee can be elected to the same position for more than 2 consecutive years, except in circumstances where the particular skills required by the position would mean that the integrity of club documents or publications may be damaged by members without the necessary skills being nominated or elected.

Any member reaching the 2 year limitation can be elected to

another position on the executive committee, and can be re-elected to their previous position (if they wish) after a period of 12 months.



drinking, we retired for the evening. Well some of us did .


Some decided to keep on drinking and having a good time and finally retired for the night quite late.


At the shooting range we all got fitted out with our ear plugs, closed in shoes etc, signed in to the visitor and members books and, yahoo, could finally start firing on the range.
