Pork skewer at \$8 wholesale price sold at \$12 generates a \$4 Profit

## Important Information 1/2

- 1. Interested investors will propose their selling areas for FATBRO to consider. In this regard, investors are prohibited from entering into a lease agreement with the landlord before AroiVer Co., Ltd. approves the franchise rights to the investor. In the event of any damages occur, AroiVer Co., Ltd. will not be liable for any damages.
- 2. Fill out the information for participating in the FATBRO Franchise business in the E-Form at www.fatbro.net/application
- 3. The consideration process will take approximately 15 business days from the receipt of all documents from the investor. After that, FATBRO will notify the area consideration results to interested investors by E-mail as specified in the E-Form. In the event that the application has been "approved", FATBRO will request additional documents that must be prepared for the FATBRO Franchisee Agreement contract.
- 4. FATBRO Franchisee rights are exclusive and non-transferable, in whole or in part, unless with written approval from AroiVer Co., Ltd.

## Important Information 2/2

- 5. The franchisee must open shop within 6 months after receiving the franchisee rights. If the franchisee does not do so within the specified period, FATBRO can cancel the right grant without prior notice.
- 6. The franchisee will invest in construction, decoration, and paying for raw materials and equipment used in the shop according to the list specified by FATBRO directly. Along with paying the fees and expenses that FATBRO charges in full before opening the store.
- 7. The franchisee must be trained one month in advance and must pass both theoretical and practical examinations to be approved for operation. All staff personel, whether sourced by the franchisee or FATBRO H&R department, will be required to undergo the same program.
