## VFW ELECTS DUANE SARMIENTO AS NEW NATIONAL COMMANDER

The New Jersey native is the first Filipino American elected to lead the 124-year-old organization

PHOENIX (July 27, 2023) — Duane Sarmiento of Gibbstown, New Jersey, was elected today as the new national commander of the Veterans of Foreign Wars (VFW), a congressionally chartered veterans service organization comprised of approximately 1 million eligible combat veterans and military service members from all six branches of the

'Today, I humbly stand here as a testament to the limitless potential of our great nation and a product of the American dream," said Sarmiento during his acceptance speech. "As



a kid from New Jersey, I never imagined I would be standing here to accept such a prestigious position in one of the most prestigious institutions in our country."

Sarmiento's election as the VFW's 115th commander-inchief occurred at the conclusion of the organization's 124th National Convention in Phoenix, Arizona. The gathering was the first national convention held

there since 2009. More than 10,000 members of the VFW and its Auxiliary converged on the city to conduct the business of the organization, recognize individuals and organizations for excellence and to elect new leadership for the 2023 - 2024 year.

Sarmiento, who is of mixed Filipino and Italian heritage, is the first person of color elected to lead the 124-year-old organization. He delivered remarks to those attending in person at the Phoenix Convention Center and watching via livestreaming video.

"As I look out into this sea of familiar faces, I am reminded of the shared experiences, the sacrifices and the bonds that have brought us together," said Sarmiento, to the delegates in attendance from all 52 Departments, which includes Europe and Asia. "We come from different walks of life, but we share a common thread — a deep love for our country and an unwavering dedication to veterans."

VFW membership eligibility requires honorable service in a war or expedition on foreign soil or in hostile waters. Sarmiento served in the United States Navy from 1988 to 1997, and the United States Naval Reserve from 2002 to 2006, earning his VFW eligibility by serving in Operations Desert Shield/Storm. In recognition of his service, he received the Navy Achievement Medal, Navy Combat Action Ribbon, Navy Good Conduct Medal, the Southwest Asia Service Medal with three campaign stars, the Saudi Arabian Medal for the

Liberation of Kuwait, Kuwait Medal for the Liberation of Kuwait and numerous other medals and ribbons. In 2003, he earned the title of the Naval Reserve Center Sailor of the Year at Fort Dix.

Throughout my time in the Navy, I witnessed firsthand the power of teamwork and the unbreakable spirit that binds us together as veterans," said Sarmiento. "Those formative years taught me so much about camaraderie and esprit de corps, it was only natural for me to join the ranks of the VFW, an organization that means so much to generations of veterans."

Sarmiento joined the VFW in 1990 at Post 5579 in Gibbstown, New Jersey, where he maintains his Gold Legacy Life membership. He has served in elected and appointed positions at the Post, District and Department levels, culminating with his election as the VFW Department of New Jersey Commander from 2018 to 2019. On the national level, he served as the VFW Inspector General from 2019 to 2020, and served on the National Security and Foreign Affairs Committee, General Resolutions Committee, and as Special Aide-de-Camp. He is a life member of the Military Order of the Cootie, at Ky-Yi Pup Tent #1 in Delaware.

"By embracing a leadership role within our organization, we can unlock its full potential, empowering the VFW to make an even greater impact on the lives of all veterans," said Sarmiento. "So, no matter at what level - Post, District or Department - step up, take the lead and you can make a difference in the VFW."

Though much of his speech was spent touting the programs, work and achievements of the VFW, Sarmiento took time to espouse the value of the members, showing his passion for the fraternal side of the organization.

"We have entrepreneurs who have built successful businesses, educators who have shaped young minds, and community leaders who have made a lasting impact. We have advocates who have fought tirelessly for the rights of veterans, and caregivers who have provided unwavering support to those in need," said Sarmiento, who retired as a police officer and director of Veterans Affairs in Gloucester County, New Jersey. "I'm here to tell you the most valuable resources to the Veterans of Foreign Wars are you - the members."

In addition to Sarmiento, other national officers elected were Al Lippardt, a Vietnam War veteran from the Department of Georgia, as Senior Vice Commander-in-Chief, and Carol Whitmore, an Iraq War veteran from the Department of Iowa, as Junior Vice Commanderin-Chief. The final day of the convention also saw Adjutant General Dan West and Quartermaster General Marc Garduno reconfirmed in their positions.

"Regardless of your pecking order in this organization, keep this in mind - you don't need a title to lead. You just need to care," said Sarmiento. "People would rather follow a leader with a heart than a leader with a title."

Sarmiento resides in Gibbstown, New Jersey with his wife Ellen.

He attended aviation ordnance school and F-14 Armament school. Jim earned his VFW eligibility by receiving two Navy Expeditionary Medals and a Southwest Service Medal. He also received two good conduct medals, three Sea Service Ribbons, and two National Defense Service Medals. He is a life member of VFW Post 3264 in Mansfield, MA. Where he has served in various positions

including Post Commander 2006-2014 earning all-state Post Commander and all State successfully remain focused on its service to veterans. Quartermaster award. Over the past few years, the health and welfare of our members, families, and the veteran community at large has been top priority. Now that we have the global pandemic in our rearview mirrors, it is not the time to ease up on the pressure and scrutiny that we have placed on state of veterans' healthcare on both the State and Federal levels. While it is exciting that the Soldiers' Home in Holyoke has finally broken ground on a new facility, we cannot take our eyes off the Executive Office of Veterans Services to ensure that they fulfill

their promise to provide world-class healthcare, to include long-term care, for all Veterans throughout the Commonwealth. The Chelsea Soldiers' Home is also off to a good start with their new facilities. The VFW needs to remain actively engaged with our comrades and family members that are residents at the Homes. It is feedback directly from them, both good and bad, that will hold the Commonwealth accountable to providing top-notch care. To accomplish this, the Commonwealth needs to hire and retain the best medical and healthcare professionals. As we live in close proximity to one of the "Medical Meccas" of the world, high quality of care is the benchmark! It should be the goal of the Commonwealth to make our Soldiers' Homes competitive, not only in quality of care, but also quality of pay and benefits of the providers. This will make our Soldiers' Homes an attractive employer to attract the best healthcare providers out there! 

# **Cracking Down on Predatory Claims Companies**

#### The VFW's Concerns:

The VFW is concerned that bad actors have been preying on veterans by seeking to access their earned Department of Veterans Affairs (VA) benefits. When the COVID-19 pandemic struck, unaccredited consulting groups that the VFW calls "Claim Sharks" viewed the chaos as an exploitation opportunity. Since the passage of the PACT Act, they have ramped up their efforts even more.

These groups aggressively advertise online and make promises to increase veterans' disability ratings. Some charge thousands of dollars in fees for their services and even request VA login credentials to track when veterans receive future ratings increases. If a veteran receives a disability percentage increase years later, often these companies return seeking more money. Furthermore, they routinely obtain medical opinions from affiliated medical providers, which raises ethical concerns.

Under VA regulations, accredited representatives of Veterans Service Organizations, like the VFW, cannot charge fees for claims services. We gladly provide these services for free. Attorneys and agents may also seek VA accreditation, and may charge certain fees that are capped and can apply only to retroactive benefits. Claim Sharks, however, avoid accreditation in order to impose exorbitant fees and avoid VA oversight. Several years ago, penalties regarding fees were removed to allow accredited attorneys and agents to charge certain fees, leaving a gap in the law that predators are exploiting. The VFW believes that penalties need to be reinstated.

Anyone who assists veterans with the preparation, presentation, or prosecution of VA claims should adhere to established fee caps or be subject to penalties.

#### The VFW urges Congress to:

Pass the *Governing Unaccredited Representatives Defrauding VA Benefits Act*, known as the *GUARD VA Benefits Act*. This legislation would reinstate penalties for charging veterans and survivors unauthorized fees relating to claims for VA benefits.



### Claim Sharks Q&A

#### Q: What makes these companies predatory?

**A:** The law prohibits anyone who assists veterans with the preparation, presentation, or prosecution of their Department of Veterans Affairs (VA) disability claims to charge fees for their services. Many of these companies use contracts that include a commitment by the veteran to pay them all or a portion of their increased benefits. If a veteran receives a disability percentage increase years later, these companies often return seeking more money. Furthermore, they routinely obtain medical opinions from affiliated medical providers, which raises ethical concerns.

# Q: Some of these companies say they would seek VA accreditation but there currently is no path for them to do so. Shouldn't our focus be on reforming accreditation?

A: This claim is untrue. Anyone can seek VA accreditation, but then would be subject to oversight by VA's Office of General Counsel and would not be allowed to charge high fees for claims assistance. The VFW is open to discussions about how to improve the accreditation process, but that does not involve making it easier for Claim Sharks to take advantage of veterans.

# Q: What does it mean when a claims representative or service officer is accredited? What is accreditation?

A: Accreditation by VA authorizes individuals or Veterans Service Organizations (VSOs) to represent veterans for their VA benefits claims. VA accreditation is for the sole and limited purpose of preparing, presenting, and prosecuting claims before VA. Accreditation requires passing extensive training and background checks. VSOs like the VFW have some of the most well-trained and professional claims representatives in the country.

# Q: Organizations that offer claims assistance for free do not have enough people to serve all the veterans who need it. Aren't these companies filling a gap?

**A:** This claim is also untrue. The VFW alone has more than two thousand accredited representatives and they helped tens of thousands of veterans receive more than ten billion dollars in VA benefits last year. No private company that charges fees even comes close to those numbers.

#### Q: Why are penalties necessary?

**A:** Consultants who refuse to adhere to VA's well-established standards of accreditation and fee arrangements should be subject to penalties in the same manner as accredited representatives. This is a much-needed protection to deter bad actors and protect veterans' earned benefits.

#### Q: Why were penalties removed in the first place?

A: Penalties were removed to allow accredited attorneys and agents to charge certain fees for their services. The unintended consequence was that this opened the door to unaccredited, predatory consultants to operate illegally without penalty. We must reinstate these penalties.



#### What is the Patriot's Pen Program?

Conducted nationwide, this VFW-sponsored youth essay competition gives students an opportunity to write essays expressing their views on an annual patriotic theme. We invite you to join the more than 73,000 students who participated last year in this contest.

#### Why Should I Enter?

Prizes and scholarships can be awarded at the Post, District, State and national level. Department (State) winners receive a portion of \$55,000 in national awards. National Winners will receive at least \$500. The first-place national award is currently \$5,000.

The Internal Revenue Service requires a recipient awarded more than \$599 be given Form 1099 identifying the proceeds as taxable income. This may require the winner to provide their social security

#### How Does the Contest Work?

All entries begin at the VFW Post level. The only exception is where schools/classes/youth groups have large numbers of students and wish to conduct their own competition, submitting one winner for each 15 students to the VFW Post. Individual students may submit their entry directly to the Post.

The contest consists of four levels. The first level (entry) is sponsored by VFW Posts. Post winners advance, one for every 15 entries, to the VFW District (regional) level where the one first-place winner is advanced to the VFW Department (state) level. The first-place winner at the Department level is then advanced into the VFW national competition.

#### Who Can Enter?

Patriot's Pen is open to 6th, 7th and 8th-grade students enrolled by the Oct. 31 deadline in public, private or parochial schools in the U.S., its territories or its possessions; or dependents of U.S. military or civilian personnel in overseas schools. Home-schooled students also are eligible. Although U.S. citizenship is not required, students must be lawful U.S. permanent residents or have applied for permanent residence (the application which has not been denied) and intends to become a U.S. citizen at the earliest opportunity allowed by law. (Foreign exchange students or former winners that placed in the National contest are ineligible.)



#### **Education Benefits**

Tuition Waiver for All Massachusetts Veterans To All State Colleges And Universities.

M.G.L. Ch. 15A, s.19 Veterans of Massachusetts, as defined by M.G.L. Ch. 4, s.7, clause 43, may be eligible for any state-supported course in an undergraduate degree program or certificate program offered by a public college or university. To be eligible, a veteran must also be a legal resident of Massachusetts and must not be in default of any federal student loans.

Veterans will be eligible on a space-available basis for a waiver of full or partial tuition based on proper documentation of the eligibility of the veteran. Space availability shall be determined in accordance with normal practices and procedures as published by each institution, i.e., the individual college or university. Contact the Veterans Representative at the college or university for details.

#### National Guard Tuition and Fee Waiver

Acts of 2005 Ch. 130 Members of the National Guard are eligible for a waiver of both fees and tuition at all state colleges and universities. Please contact the college or university Veterans' Representative for details about this program.
