The cord end and extension cord were replaced, and a weather-proof cord cap was installed to prevent recurrence. Ensure all cords and connections remain protected from moisture to avoid similar incidents.

To address this, an RFI was submitted for clarification. A resolution was quickly reached, and it was determined that the pad would be extended based on the drawings provided by TDS.

Oct 2. 2025		Hi-Line	Hastings Harl	During the load out of the Valmont Tilt Cart for delivery, Torian Gray noticed the shackle bolt on the crane hook was not fully threaded into the shackle. After he informed myself of this, I stopped the load out, cribbing was placed under cart for support, then cart was lowered on to the cribbing. After checking stability of the cart, we were able to lower the crane to fully thread the bolt into the shackle, and then resumed the load out of the cart.

While working in the area, I observed another contractor hoisting employees in and out of a 12' diameter, 13' deep backwash vault using a confined space rescue tripod without a ladder. This raised alarms for me, and I want to ensure that the necessary precautions are being taken to keep everyone safe. I have already alerted the CDM Smith safety team to get their input on the safety of this practice. We must ensure all safety measures are in place to avoid any potential hazards. While this wasn't IWS employees, we all must do our best to keep everyone around us safe.

This could lead to possible fire or electrical shorting.

Lesson Learned: Always watch for road debris and ensure spare tire and tools are ready before trips to prevent delays or accidents.
Sep 8. 2025	Texas	Gatehouse	Jason Vargas	Went to check on Diamondback subcontractor and noticed nobody was spotting for the operator when excavating a trench, so I spoke to them about the importance of spotting, and then sent them help from one of my guys to show them what they should be looking for
Sep 10. 2025	New Mexico	Santo Domingo	Jay Carpenter	Larry checked the concrete sub footing layout and found that the orientation of concrete layout was off by two feet and height of walls by 5'. Determined that they were using the rebar drawings for layout not the stamped plans.

Sep 8. 2025	New Mexico	Pojoaque	Erik Christensen	While i was inspection our work area, I noticed one of the other contractors had set up a trash pump to remove water from a site drain. I noticed the drain was half way barricaded with some saw horses. I immediately contacted the safety team at CDMSmith and reported this open hole. Cdmsmith sent someone out right away and addressed this serious open hole infraction. IWS stay near open hole until it was properly barricade. This issue was also discussed the next morning during the daily safety meeting.

This created uncertainty since the system is designed for 480 Volts. Upon further investigation, the team was certain the pumps were wired incorrectly and took corrective action by contacting the supplier. The pumps will be sent back to the manufacturer to be re-wired to the required 480 Volts. Moving forward, all submittals should identify and relay voltage requirements upon approval.

The chemical system requires two different chemical outlets (one for each pump) since there are two chloring injection points. After reviewing the submittal and talking with the design team, we came to the conclusion to adjust the submittal and send it back to the vendor with instructions and changes to the chemical skid to adhere to two injection points. Catching this issue early allowed for us to take corrective action right away, minimizing any delays that would have stemmed from this situation.

The outer jacket of the double insulated cord was stripped away exposing the conductors.</p> <p>We generally try not to run the cords over with equipment and route the cords away from traffic areas. The cords are bright colored so they can be seen easily to prevent being ran over or tripped over. This is a good discussion point. Electricity can be dangerous, it is safest roll up cords while they are unplugged and inspect before each use for nicks in insulation. For outdoor and garage or basement outlets the branch circuit or outlet needs to be GFCI protected and tested before each use. This time the cord was immediately taken out of service to prevent electric shock</p>

As a result, field crews have been required to perform manual modifications on every new bluBox installation. Supporting photos have been attached for reference. This issue is currently adding approximately 5-8 manhours per unit to the installation process.</p> <p>Rolan Vargas is familiar with the situation and can provide additional insight if needed. Addressing this issue during fabrication presents an opportunity to improve manufacturing accuracy and reduce unnecessary field labor on future installations.</p>

When i pulled up the worker was standing inside the manlift preparing to move it. I asked him were his harness was. He told me he wasn't going to move it very far. I told him to stop and explained to him that just because he was only going to move it a short distance, it is still highly dangerous and is considered high risk.
