# RULES OF THE MEETING

ONLY **CITIZENS OF THE RED RIVER METIS**, REGISTERED AS MEMBERS OF THE LOCAL, ON THE DATE OF THE MEETING WILL BE **ENTITLED TO SPEAK** AT THE MEETING, **RUN FOR OFFICE**, OR TO **VOTE** ON THE ISSUES RAISED.

TO BE ELIGIBLE, A CITIZEN MUST REGISTER WITH THE OFFICE OF THE CHIEF ELECTORAL OFFICER. To Register, please email [amber.stevens@mmf.mb.ca](mailto:amber.stevens@mmf.mb.ca) and provide a copy of your MMF Citizenship Card and/or Valid photo identification.

CITIZENS CAN BE NOMINATED IN ADVANCE BY NOTICE IN WRITING, signed by two citizens that are members of the local. The nominee must also sign **ACCEPTING THE NOMINATION** and **DECLARING** for which position or positions they wish to be considered. To be accepted, the chief electoral officer must receive such nomination by 4:30 pm on **September 2nd, 2024**. **NOMINATIONS WILL ALSO BE ACCEPTED FROM THE FLOOR OF THE MEETING ON THE DAY OF THE ELECTION**. Persons nominated from the floor must either accept in person or by signed letter.

THE CHIEF ELECTORAL OFFICER SHALL CONDUCT THE MEETING ACCORDING TO ROBERTS RULES OF ORDER. His decisions shall be final and binding. Winning candidates must receive 50% of the votes cast.

THE ELECTIONS SHALL TAKE PLACE IN THE FOLLOWING ORDER:

1. SECRETARY
2. TREASURER
