This premium offering features a fully operational, permitted dairy facility, prime open farmland planted to almonds, corn, and wheat. Property has a primary residence and five (5) mobile home units on-site. Excellent water resources, modern infrastructure, and large-scale production capacity make this property ideal for investors or operators seeking a turnkey operation with both commercial and residential components.

Acres: 637.22 +/- gross acres. Dairy facility is 100 +/- acres, almonds are planted on 65 +/- acres, and remaining 472.22 +/- acres of open farmland. Open farmland is regularly planted to corn (currently) and wheat.

Permitting: From California Regional Water Quality Control Board 2,160 with 15% not to exceed 2,484 total head, supporting stock 1,800 head.

Milking Parlor: Double 25 Herringbone (currently operating as Double 20)

Equipment: 2 milk tanks (+6,000 gallons total capacity), 2 water heaters and storage tanks, air compressor and variable-speed vacuum pump, crowd gate system, 40 milk machines with pulsators, and 4 ice machines.

Structures: 2 hay barns (1,000-ton capacity each) and commodity barn.

Farmland Details: 65 +/- acres of almonds and remaining 472.22 +/- acres of open farmland. Open farmland is regularly planted to corn (currently) and wheat. All irrigated by pipeline.

Herd: Mature milking and dry cows 1,800 +/-, Day old heifers to springers 2,000 +/- and Quota solids non-fat 222.90.

Irrigation and Water: Property has 1 (250 HP) well, 4 (125 HP) wells, and 3 submersible wells (dairy and home use). Located in the McMullin GSA.

SGMA Disclosure: The Sustainable Groundwater Management Act passed in 2014 requires groundwater basins be sustainable by 2040 and requires Groundwater Sustainability Plans (GSP) by 2020. 




