

## Industrial Wind Turbines and Agriculture

Clear Skies Above Barre, Inc.

**Industrial Wind Turbines** 

- Monitored by the Department of Public Service- not Agriculture and Markets
- Generate electricity from wind (which is not cultivated and therefore can not be harvested)
- Uses viable Agricultural land
- As their name implies are "Industrial"

How much agricultural land will be developed?

- 33 wind turbines (1/4 acre each= 8.25 acres
- approx. 57 miles of associated 34.5 kilovolt (kV) collection lines (below grade),(1') 6.90 acres
- 15 miles of access roads,(12' road) 21.82 acres
- permanent meteorological tower(s), .1 acre
- one operation and maintenance (O&M) building
  1.5 acres
- temporary construction staging/laydown areas.
  15 acres which they will pack with gravel

## 2019 Town of Barre Wind Ordinance

"The total tip height for each wind energy conversion unit cannot exceed 500 feet as measured from the base of the unit to the tip of the unit's longest blade."

Current Town Board- January 2019

#### Lessons Learned?

"Care must be taken by Article 10 applicants to avoid, and we as regulators must ensure against, giving in to the attitude of the pure entrepreneur, The pure entrepreneur only cares about closing the deal, its deal, today's deal, by hook or by crook, by trickery or intimidation, close a deal, cash out, move on. That's a dangerous attitude, which if taken too far will kill the Article 10 process."

## NYS Putting the Cart before the Horse



Clear Skies Above Barre, Inc.

The upstate grid is 87% carbon emission free energy (Robert Moses Niagara hydro + St Lawrence nydro+ 4 nuclear reactors + solar + wind) while the downstate grid is only 28% carbon emission free.



NYS is full of electric transmission bottlenecks that limit the flow of electricity from upstate to downstate. 80% of the state's transmission lines were built before 1980.

"Even with the Western New York and AC Transmission projects already selected by the NYISO, congestion on the system will persist, complicating the state's ability to meet its renewable energy goals. policy goals."

# Heritage Wind Supported by NYSERDA?

In its most recent award of REC contracts announced in January 2019, NYSERDA noted that it was supporting 20 large-scale renewable projects representing 1,654 MW of installed capacity. 18.93% of the awarded capacity will be located upstate (in load zones A-E), where clean energy resources are already abundant and access to load centers in southeastern New York is heavily constrained. ## So What?

"Absent investment to expand the transfer capability of the bulk power system, investment in renewables in upstate load zones runs the risk of bringing diminishing returns in terms of progress toward both renewable energy production and carbon dioxide emissions reduction goals. This is largely because nearly 90% of the energy produced in upstate New York already is derived from carbon-free resources. Because load in the region is not projected to grow, the addition of new renewable resources increasingly displaces other sources of clean generation in the region." - 2019 **Power Trends**

 Heritage Wind would create jobs and generate an entirely new source of long-term revenue for schools, government, and landowners. The total direct financial impact to the region is likely to be in the millions of dollars over about 30 years, with additional indirect economic benefits greatly exceeding that number.

- Developed and constructed with private capital, the project is expected to enter a Payment in Lieu of Taxes (PILOT) agreement with the local tax jurisdictions and a Host Community Agreement (HCA) with the town. These payments to the taxing jurisdictions for a 147 MW project are projected to total over \$1.5 million per year.
- Landowners with wind facilities on their property would receive annual lease payments. These payments would continue over the projected **30-year lifespan** of the wind farm, injecting millions of dollars into the economies of **Niagara County** and Orleans County to support local merchants, contractors, equipment suppliers, auto dealers, and others.

The power from Heritage Wind would be delivered into the New York electrical grid, which is managed by the New York ISO (NYISO).

## Is this a Property Rights Issue?

Town of Barre Zoning Ordinance 350-29: Purpose. The purpose of these regulations is to provide comprehensive time, place and manner restrictions on signage, including, but not limited to, controls on size, height, quantity, location, spacing, shape, lighting, motion, design and appearance for the purpose of promoting community aesthetics, traffic safety, economic development and the protection of property values.

B. Sign permit required. A sign permit is required for all outdoor advertising signs, subject to the following standards:

(1) General advertising signs related to the permitted use of the premises are allowed, including secondary advertisement of products or services.

(2) Brand name sponsored signs are permitted, provided that the brand name, logo, trademark (or the combination thereof) shall not exceed 25% of the square footage of the sign

(3) Signs shall be informative, enhance the rural character of the community, and shall be consistent with the Town of Barre Comprehensive Plan. Signs that are manufactured from wood, or wood simulated products, or stone, or stone simulated products (with the appearance of natural wood or stone) are recommended.

  - Orleans County Legislature in a letter to Governor Cuomo:
    - "comprehensive health impact and environmental studies including consideration for the added potential for sleep disturbances from pulsating night noise dominated by low frequency and infrasound, especially under stable atmospheric conditions."
  - Madison County Iowa- Number 2 in the Country for Industrial Wind Turbines (6,974MW)
    - "Resolved that the Madison County Board of Health determines that there is the potential for negative health affects associated with commercial wind turbines and that current setbacks are inadequate to protect the public health. The Board encourages those entities with jurisdiction within the County to require a one and one-half (1-1/2) mile setback from non-participating residences for future wind turbine projects."
