# 7. Medical Director's Report

Dr. Yin reported:

- **COVID** Cases decreasing globally. BA-5 variant continues to rise. Hospital admissions slightly up but not what we were seeing during the past surges.
- Monkeypox Cases increasing in the Lower Peninsula, with currently 72 positives in Michigan. U of M is looking into tracking Monkeypox through wastewater.
- Boat Safety Michigan is in the number three position for number of boats registered. There were 159 accidents reported with 31 fatalities in 2020. In Michigan, if born after 1996 you must take a boating safety course, aside from the Coast Guard requirements of life jackets, fire extinguishers, marine radios or cellphones, anchor and working navigation lights. It is important to make someone aware of when you will be on the water and when you plan to return.

Electrical Shock Drowning: Occurs when proper marine grade wiring isn't used.

 Carbon Monoxide Poisoning: Common on houseboats, but can also occur on powerboats with a wide flat transom. May also affect an individual who is body surfing while hanging on a swim platform at the back of the boat.

o **Prevention:** Use marine grade power cords. Purchase a marine carbon

monoxide protector and avoid idling vessels.

 Summary: Take a boating safety course, wear a life jacket, don't swim around marinas with power cords, avoid alcohol while driving a boat, and be aware of the possibility of carbon monoxide.
