These grants are provided for projects that educate the public about pollution problems and demonstrate effective alternatives, as well as those that encourage the adoption of new management techniques or measures.

STOCK REMOVAL

This service provides up to 12 animal removals to Warren Co. residents. We partner with Warren Co. Stormwater Management to provide this program after grant funds have been depleted.

WCCD has provided multiple rain barrel and composting bin workshops!






