in the County of Pasco and State of Florida, on the 28th day of July, in the year of our Lord, two thousand six, in the County and State aforesaid unlawfully and from a premeditated design to effect the death of Derek Pieper, did discharge and shoot the said Derek Pieper with a firearm, and as a direct result thereof, the said Derek Pieper died; contrary to Chapter 782.04(1)(a)/775.087/777.011, Florida Statutes, and against the peace and dignity of the State of Florida. BEFORE ME, A JUDGE OF THE CIRCUIT COURT, in and for said County, personally came Det. Lisa Schoneman, who, being duly sworn, says that on the 28th day of July, 2006, in the County aforesaid, one LUC PIERRE CHARLES, unlawfully and from a premeditated design to effect the death of Derek Pieper and/or Raymond Veluz, did by shooting the said Derek Pieper and/or Raymond Veluz with a firearm, and as a direct result thereof, the said Derek Pieper and/or Raymond Veluz died; contrary to Chapter 782.04(1)(a), Florida Statutes, and against the peace and dignity of the State of Florida. [L2]

Your Affiant had occasion to become involved in the investigation of a double homicide which occurred on July 28, 2006 at approximately 5:15 a.m. at 35744 Trilby Rd., Trilby, Florida 33525. At that time, the bodies of Derek Pieper and Raymond Veluz had been discovered with multiple gunshot wounds laying face down in the roadway. Your Affiant was advised by Det. Stephen Foshey that there was approximately seventeen .9 mm spent casings found at the crime scene. Your Affiant was further advised by John Romeo from the Florida Department of Law Enforcement that the spent casings which were taken into evidence were fired from two

separate firearms. Through the course of your Affiant's investigation, your Affiant learned from Dr. Noel Palma who performed the autopsies on Derek Pieper and Raymond Veluz that the cause of death was multiple gunshot wounds and the manner of death was homicide.

Your Affiant had occasion to speak to Angel Brooks who advised your Affiant that in the early morning hours of July 28, 2006 she had observed LUC PIERRE CHARLES and TYREE JENKINS in a dark colored car with Derek Pieper and Raymond Veluz in the back seat. Shortly thereafter she advised your Affiant that she overheard LUC PIERRE CHARLES on a speaker phone stating, "You need to pray!" She positively identified the caller as LUC PIERRE CHARLES since she knows him and can identify his voice. She could also hear the voices of two male subjects stating, "Please don't!" Ms. Brooks advised your affiant that in the early morning hours of July 28, 2006 she came into contact with LUC PIERRE CHARLES who stated, "I made them pray, I emptied the clip on them." At the time, TYREE JENKINS was laughing and also stated, "We took the car to River Road and burned it."

Your Affiant learned through investigation that LUC PIERRE CHARLES and TYREE JENKINS wanted Derek Pieper to give them a location of a rival drug dealer, Steven Pleasant. Derek Pieper refused to participate and give any information.

Your Affiant had occasion to speak to Donovan Parker who advised your Affiant that he had been to Jamal Sampson's residence on July 28, 2006 or July 29, 2006. At that time, Jamal Sampson

showed him a black bag which contained clothing, and tennis shoes, and stated, "These are the clothes they had on when they shot those boys" referring to LUC PIERRE CHARLES and TYREE JENKINS. Mr. Sampson further stated to Donovan Parker, "I have to get rid of them, I have to burn them." Your Affiant was further advised that at approximately 2 weeks later while Mr. Parker was at Grown Folks he came in contact with TYREE JENKINS. TYREE JENKINS stated, "Ain't nobody going to fuck with me, I left two dudes stinking, laying flat!" Mr. Donovan further advised your Affiant that, at the time Mr. Jenkins made this statement, he believed TYREE JENKINS had a .9 mm pistol in his waistband. As he made the above statement, he patted his waistband. This was confirmed by Angel Brooks who was also present when the statement was made.

Your Affiant was further advised by Donovan Parker that between July 28, 2006 and August 13, 2006 that Mr. Parker had come in contact with LUC PIERRE CHARLES. At that time, LUC PIERRE CHARLES stated to him, "Me and TYREE JENKINS did the murders in Trilby." As he prepared to give him more information another individual walked up at which time LUC PIERRE CHARLES stated to Donovan Parker, "I'll get with you later."

Your Affiant had occasion to speak to John Blanford on May 14, 2007 who advised your Affiant that LUC PIERRE CHARLES had confided in him and admitted to killing the victims and being responsible for Jeremy Henry's death. In addition, he further advised your Affiant that LUC PIERRE CHARLES had called the boys over a drug issue. LUC PIERRE CHARLES said there was a girl with


him who stayed behind along with Jeremy Henry. LUC PIERRE CHARLES and TYREE JENKINS drove with the boys with the intention of robbing them. The boys didn't have any drugs and wouldn't call anyone so they began beating the boys. LUC PIERRE CHARLES stated they wanted to "bag their first body." LUC PIERRE CHARLES and TYREE JENKINS then took the boys to Trilby, made them get on their knees and say their prayer and shot them in the head. LUC PIERRE CHARLES advised that he and TYREE JENKINS shot the boys. He further advised that they then burned Raymond Veluz' vehicle, which had been used in the homicide.

Your Affiant confirmed that Raymond Veluz' 1998 black Mitsubishi had been burned on River Road on 2006 at approximately 7:12 a.m.
