6 AUTOMATED VOICE: Press 1 to place a call.

7 (Dialing numbers.)

8 AUTOMATED VOICE: Please enter your PIN number
9 followed by the pound sign.

10 (Dialing numbers.)

11 AUTOMATED VOICE: After the tone please say your
12 first and last name.

13 MR. HARRIS: Anthony Harris.

14 AUTOMATED VOICE: Thank you.

15 Press zero to make a collect call or speed dial
16 call. Press 1 to make a --

17 (Dialing numbers.)

18 AUTOMATED VOICE: Press --

19 (Dialing numbers.)

20 AUTOMATED VOICE: Your account balance is 58 cents.

21 Press --

22 (Dialing numbers.)

23 (Phone ringing.)

24 CAROLYN: Hello?

25 AUTOMATED VOICE: Hello. You have a prepaid call

1 from Anthony Harris, an inmate at Pasco County Jail.
2 Your account balance is \$6.25. To hear the charges for
3 this call, press 2. To accept this call, press 5. To
4 refuse this call --

5 (Dialing numbers.)

6 AUTOMATED VOICE: This call will be recorded and
7 subject to monitoring at any time. Thank you for using
8 I.C. Solutions. You may begin speaking now.

9 MR. HARRIS: Hey. How you doing, Grandma?

10 CAROLYN: Hey, Tony.

11 MR. HARRIS: What's up? You called my attorney?

12 CAROLYN: No.

13 MR. HARRIS: Call my attorney, please.

14 CAROLYN: Okay. What's the number again?

15 MR. HARRIS: (727)824-5727.

16 CAROLYN: Oh, 824.

17 All right.

18 MR. HARRIS: Hello?

19 ASHLEY: Hello. Hi. This is Ashley.

20 MR. HARRIS: Hey. How you doing, Ashley. This is
21 Harris.

22 ASHLEY: Hey. How are you?

23 MR. HARRIS: I'm doing fine. And yourself?

24 ASHLEY: Good. I'm good.

25 MR. HARRIS: Okay. My Grandma told me she had spoke

1 to you.

2 ASHLEY: Yes.

3 MR. HARRIS: What -- what -- what did Kelly say?

4 ASHLEY: Kelly said that she did speak with the
5 State, and if you still comply with testifying, you
6 know, at the trials for the people that you have
7 information on, then, basically, you would have to --
8 you would have to -- if you leave, they will transport
9 you back, but they're not going to reduce your sentence
10 until you testify. Then once you testify, Kelly will
11 have to do a motion to reduce the sentence based off of
12 your information that you testified for in the cases,
13 and then they would reduce your sentence.

14 MR. HARRIS: Okay.

15 ASHLEY: So she said on Friday she would be out
16 there to see you within like four days, so she should be
17 out there soon. I'm going to say probably tomorrow,
18 because she doesn't have too much going on, in the late
19 afternoon.

20 MR. HARRIS: All right. Well, yeah, that's great
21 news. That's great news.

22 ASHLEY: But if you do leave for DOC, have your
23 grandma call me. Either way they're going to transport
24 you back when these five trials are.

25 MR. HARRIS: Okay. So, basically -- okay. If she

1 doesn't -- what I was trying to say, I might be going
2 back to prison Thursday.

3 ASHLEY: Right. And -- and I told her that. So
4 she's definitely going to try to come out there to see
5 you before that.

6 So -- sorry. So I told her, you know, you might be
7 leaving. She said she's going to try to get out to you
8 within like four days and that was on Friday. So I'm
9 thinking, you know, probably either maybe late tonight
10 or tomorrow late afternoon.

11 MR. HARRIS: Okay. Okay. I appreciate that.

12 So, basically --

13 ASHLEY: No problem.

14 MR. HARRIS: So, basically --

15 ASHLEY: I'll stay on top of her for you.

16 MR. HARRIS: Okay. So, basically, she talked to
17 them and they did, you know what I'm saying, basically
18 agreed once I get done with everything --

19 ASHLEY: Yeah. If you testify, you know, based off
20 the information that you had, you know --

21 CAROLYN: Excuse me. What about the money he paid
22 her to do --

23 MR. HARRIS: That's what she's doing, Grandma.
24 That's what she's doing. What is you talking about?

25 ASHLEY: She's been communicating with the State

1 Attorney to get him that arrangement.

2 MR. HARRIS: Yeah. That's what she's already doing.
3 I'll talk to you about that when she get off the phone,
4 Grandma, because -- but this is what I'm going to say
5 right here: So, basically what you saying is she talked
6 to them and they agreed with her after --

7 ASHLEY: They're agreeing that if you're still going
8 to comply with testifying at trial, then they will, you
9 know, reduce your sentence.

10 She did not -- at the time she didn't have an amount
11 of time that they would knock off but, usually, when
12 people do this, it is a significant amount of time that
13 they do knock off --

14 MR. HARRIS: Yeah. I already know that.

15 ASHLEY: -- if your testimony is very useful to
16 them.

17 MR. HARRIS: All right. Well, tell her I said, you
18 know what I'm saying, you know, if she could just, if
19 it's God will, you know, try to get out here before I go
20 back to prison so I could talk to her.

21 ASHLEY: Yeah. And I told her that. I said he's
22 very, you know, anxious. He needs to see you before he
23 leaves.

24 She's like, I know. She's like, Well, when does he
25 think he's going to leave?

1 I said, Thursday.

2 She's like, Okay, tell him to give me like three to
3 four days. And that was Friday.

4 MR. HARRIS: Okay. Well, everything is --

5 ASHLEY: Okay? So just kind of hang tight and I'll
6 let her know that I spoke to you again this afternoon,
7 okay?

8 MR. HARRIS: All right. Thank you, Ash -- hey,
9 Ashley, did anybody give you all a call considering
10 trying to hire you all?

11 ASHLEY: Hire her? Not from where you are, no.

12 MR. HARRIS: Well, there was somebody that was
13 supposed to had gave you all a call from here.

14 ASHLEY: Do you have a name?

15 MR. HARRIS: Yes, I can get his name right quick.
16 Hold up right quick.

17 ASHLEY: Okay.

18 MR. HARRIS: Hey, Blunk (phonetic). Hey,
19 (inaudible). I'm talking to my attorney. What's your
20 name, bro?

21 What?

22 His name D'Angelo Thomas. His mother -- his mother
23 supposed to be giving you all a call or his auntie. She
24 said they supposed to give you all a call Tuesday, so
25 you all will probably be getting a call from them

1 Tuesday. I referred them to you all, so.

2 ASHLEY: Okay. I will pass that information on,
3 okay?

4 MR. HARRIS: All right. Thank you. I appreciate
5 it.

6 ASHLEY: Okay. You're welcome. Bye.

7 MR. HARRIS: All right.

8 (Ashley hangs up and is no longer on the call.)

9 MR. HARRIS: Yo, Grandma, listen, man. You going --
10 what you was going to say? They already doing their
11 job?

12 CAROLYN: Tony, if you didn't test -- listen to me.
13 You paid the lady \$1,500 to adjust your sentence.

14 MR. HARRIS: Yeah, and that's cheap.

15 CAROLYN: And if you don't testify --

16 MR. HARRIS: They're not going to reduce it.

17 CAROLYN: But, Tony, that ain't got nothing to do
18 with it. Tony, you know --

19 MR. HARRIS: Man, Grandma, Grandma, Grandma, before
20 you talk, Grandma, don't be telling me what it got to do
21 with, and I'm in jail and I know law. You don't even
22 know law. Don't be telling me what -- you don't even
23 know what you're talking about.

24 CAROLYN: All right.

25 MR. HARRIS: Please don't do that. Don't -- don't

1 do that. Please, Grandma, don't do that, because you're
2 trying to tell me something that I know.

3 CAROLYN: Uh-huh.

4 MR. HARRIS: Come on, man. Damn, Grandma. You know
5 I love you. Don't be doing stuff like that. That's why
6 I hired her for. That's why I hired her for, for her to
7 make sure, you know what I'm saying, something, you know
8 what I'm saying, get considered as to what I do. And
9 she said once I get done, they're going to file a
10 motion, you know what I'm saying, to reduce time.
11 That's in the law. That's how they supposed to do it.
12 So she's doing it right. I done read the law. I know.
13 You understand?

14 That's why I hired her for, to make sure she talk
15 with them and make sure, you know, if there's something
16 going on.

17 So, basically, they done told her that once I do
18 that, then they will do that. So, basically, that's
19 coming from her mouth. So she's a witness and she know
20 what they told her. She's a paid lawyer.

21 CAROLYN: Uh-huh.

22 MR. HARRIS: So everything looking great. That's
23 what I was going to tell you before you started talking.

24 I didn't pay her to represent -- how she's going to
25 represent me in a case that's closed already?

1 She's representing me to make sure my stuff that I
2 got going on be done correctly and beneficial to me.

3 CAROLYN: Well --

4 MR. HARRIS: That's what I hired her for. If I was
5 trying to hire her to fight my case and stuff, that
6 would be more than \$1,500.

7 CAROLYN: Okay, Tony. Okay.

8 MR. HARRIS: Yeah, Grandma, everything is all right.
9 Everything is all right.

10 That's all I wanted her to do, to make sure she
11 talked to the State so she could get, you know what I'm
12 saying, a consensus as to, you know -- she said a
13 significant -- a significant amount of time will be
14 reduced, and it is because of what I got going on.

15 Now, before the phone hangs up, I need you to call
16 this number right here for me. What's the number?
17 (813)918 -- no. (813)202-6 -- 202-7366.

18 Yeah, that was great news.

19 CAROLYN: Now you say it.

20 MR. HARRIS: (813) --

21 CAROLYN: (813).

22 MR. HARRIS: -- 202 --

23 CAROLYN: Uh-huh.

24 MR. HARRIS: -- 7366.

25 CAROLYN: Okay. 7 --

1 MR. HARRIS: 366.

2 CAROLYN: 7366. Okay.

3 Tony?

4 (Phone ringing.)

5 MR. HARRIS: Hello. Yeah. I'm on the phone. Just
6 wait. You got to wait until it come through.

7 MALE VOICE: You have reached the desk of special
8 agent --

9 MR. HARRIS: All right. Hang that up.

10 All right. Check me out. Call this number right
11 here, (813)918-6013.

12 AUTOMATED VOICE: This call has been forwarded to an
13 automated voice messaging system. 813 --

14 MR. HARRIS: All right. Hang that up.

15 All right. Call this number right here, (727) --

16 CAROLYN: Tony, I got to get to the toilet. I got
17 to go to the toilet. I'll call your momma.

18 MR. HARRIS: Oh my God. That's just wasting time
19 off my phone.

20 PATRICIA: Tony?

21 MR. HARRIS: Yeah.

22 PATRICIA: Hey, Tony. What's up?

23 MR. HARRIS: What's up, Momma? What's going on?

24 Hey, check me out. Before we go to talking, call
25 this number right quick, (727)657-9447.

1 PATRICIA: What?
2 MR. HARRIS: (727) 657 --
3 PATRICIA: Uh-huh. 657.
4 MR. HARRIS: -- 9447.
5 PATRICIA: 944?
6 MR. HARRIS: 7. 9447.
7 PATRICIA: Okay. 9447.
8 MR. HARRIS: Yeah.
9 PATRICIA: 727 --
10 MR. HARRIS: 657-9447.
11 PATRICIA: 657-9447.
12 MR. HARRIS: Yeah.
13 CAROLYN: Hello?
14 MR. HARRIS: Yeah.
15 (Phone ringing.)
16 PATRICIA: Tony?
17 MR. HARRIS: Yeah. Yeah.
18 MICELLE: Hello?
19 MR. HARRIS: Hey. This Michelle?
20 MICHELLE: Yeah. Who is this?
21 MR. HARRIS: Hey. How you doing? I'm calling for
22 your boyfriend, Bony. He in lockdown.
23 What you want me to tell her, Bro?
24 MICHELLE: Why he get put in lockdown today, because
25 he's arguing with a white boy?

1 MR. HARRIS: Yeah. He said set a visit.

2 I can't talk to you too long because my phone
3 running up, but he said -- he said set a visit. He
4 can't get on the phone so he sending a message through
5 me. So set a visit so you can come see him. He in
6 lockdown.

7 MICHELLE: How long he in lockdown for? Do you
8 know?

9 MR. HARRIS: I don't know. He don't know yet.

10 MICHELLE: All right. All right. Thank you. I
11 appreciate you.

12 MR. HARRIS: Yeah. No problem.

13 MICHELLE: I knew something was wrong. Thank you.
14 That mother fucker always going in some goddamn
15 lockdown.

16 (Michelle hangs up and is no longer on the call.)

17 MR. HARRIS: All right. Ma, you can click it off.

18 PATRICIA: Okay.

19 MR. HARRIS: Hey. I'm a tell you -- hey, check me
20 out. Call this number, Ma.

21 PATRICIA: What?

22 MR. HARRIS: (727)277 --

23 PATRICIA: 727 --

24 MR. HARRIS: 277-7171.

25 PATRICIA: I can't hear you.

1 MR. HARRIS: (727) --
2 PATRICIA: Tony? 727 --
3 MR. HARRIS: 277.
4 PATRICIA: 277.
5 MR. HARRIS: 7171.
6 PATRICIA: Oh, okay.
7 (Phone ringing.)
8 PATRICIA: Hello?
9 MR. HARRIS: Yeah. I'm on the phone.
10 AUTOMATED VOICE: One minute remaining.
11 PATRICIA: I seen Jayden yesterday.
12 MR. HARRIS: All right. Hang it up. Hang it up.
13 It said one minute remaining.
14 All right. You seen Jayden?
15 PATRICIA: Uh-huh. I took her \$50 for him.
16 MR. HARRIS: Man, you shouldn't had did that.
17 PATRICIA: Huh?
18 MR. HARRIS: You shouldn't have did that.
19 PATRICIA: Why?
20 MR. HARRIS: Because.
21 PATRICIA: Because what?
22 MR. HARRIS: Because I need all that.
23 PATRICIA: Boy, please. (Inaudible) You is sick.
24 MR. HARRIS: I need all that. I'm already in here
25 struggling about my phone and all that. You should --

1 you should have gave him \$20.

2 PATRICIA: Man, let me tell you something. I ain't
3 seen my grandson in so long . . . It was not even
4 enough if you ask me.

5 MR. HARRIS: Yeah. I feel you.

6 How you doing? You all right?

7 PATRICIA: Yeah. She doing okay. Look like she
8 depressed.

9 MR. HARRIS: Yeah. She depressed because that boy.
10 But --

11 PATRICIA: Yeah. It look like she depressed.

12 MR. HARRIS: I'm trying to get out there as fast as
13 possible. I talked to my attorney. I got good news.
14 She said that she talked to the State and they said that
15 they would --

16 AUTOMATED VOICE: Thank you for using I.C.
17 Solutions. Good-bye.

21 MR. HARRIS: Hey, Grandma, call Wayne-Wayne right
22 quick.

23 Hello?

24 CAROLYN: Hello?

25 MR. HARRIS: Hello?

1 CAROLYN: Hey. What's up?

2 MR. HARRIS: What's up? Man, Grandma, I told you to
3 call Wayne-Wayne.

4 CAROLYN: Oh. I don't know Wayne-Wayne number,
5 baby.

6 MR. HARRIS: Man.

7 CAROLYN: Momma know it.

8 MR. HARRIS: What's Wayne-Wayne --

9 PATRICIA: You got a pen? 766 -- because I'm
10 cooking me something to eat.

11 CAROLYN: Okay. Hold on. Hold on.

12 MR. HARRIS: Hold on. Let her get a, Grandma. Let
13 her get a pen. Hold up. Let her get a pen.

14 Hello?

15 CAROLYN: Okay. I got my pen. No. This. Is a dog
16 gone -- oh, Lord have mercy.

17 Okay. I gotta crayon.

18 MR. HARRIS: All right. What's the number, Grandma?

19 CAROLYN: Give it to me.

20 PATRICIA: 78 -- 786 --

21 CAROLYN: 783 --

22 MR. HARRIS: 786.

23 CAROLYN: Okay. 786.

24 PATRICIA: 423.

25 MR. HARRIS: 423.

1 PATRICIA: 73 --

2 CAROLYN: 73.

3 PATRICIA: 17.

4 CAROLYN: What?

5 MR. HARRIS: 17.

6 CAROLYN: Okay. Hold on.

7 MR. HARRIS: All right.

8 (Phone ringing.)

9 CAROLYN: Tony?

10 MR. HARRIS: Yeah. Yeah. Yeah. Yeah. Yeah.

11 CAROLYN: Okay.

12 WAYNE: Hello.

13 MR. HARRIS: Hey. What's up? What's up? What is
14 it, cousin? What's going on?

15 WAYNE: (Inaudible.)

16 MR. HARRIS: Man, I'm chilling, man. Chilling out.
17 You know what I'm saying?

18 My lawyer -- I talked with my attorney today. They
19 gave me good news. She says she -- she talked to the --
20 she talked to the State, and she said, you know what I'm
21 saying, they -- they willing to, you know what I'm
22 saying, work with me. You know what I'm saying?

23 She said they going to reduce my time once I get
24 done doing what I need to do. You feel me? So, you
25 know, that looking good, man.

1 She coming up here to see me before I go to prison.

2 Hello?

3 WAYNE: I'm here.

4 MR. HARRIS: Yeah. So she said that they're going
5 to reduce a significant amount of time. You know what
6 I'm saying? Once I'm done doing what I'm doing, she
7 gonna file a motion to get my time reduced, and they
8 said that they will reduce it already. So that is great
9 news, man.

10 They agreed -- they agreed to it and said they will
11 reduce it, so. You know what I'm saying?

12 WAYNE: They say how much?

13 MR. HARRIS: She said her goal was 10.

14 You heard me?

15 WAYNE: Yeah, I heard you.

16 MR. HARRIS: Yeah. She said 10 years.

17 I'm pretty sure they're going -- I'm pretty sure
18 they're going to do the 10 years. She said, you know,
19 they agreed to reduce it, and she told them 10 years.
20 So, basically, they saying yeah. They said yeah to what
21 she said.

22 You know, basically, I got to wait to August --
23 August and September, when them boys trial come up, and
24 once -- you know what I'm saying? Once I get done, all
25 that stuff will get dropped and I'll be coming home,

1 man, in the next year or two. You know what I'm saying?

2 PATRICIA: Hey, Tony?

3 MR. HARRIS: Maybe a year. They probably push me
4 right out the door. I got to calculate all my time up.

5 PATRICIA: Right. Tony?

6 MR. HARRIS: Yo.

7 PATRICIA: So you don't know how much time you got
8 right now?

9 MR. HARRIS: Well, I know they gave me -- they gave
10 me -- I took the 20, no mandatory, eight years, that put
11 me at 12. 85% of 12, that was nine years. And if she
12 gets 10 years took off, that'll push me -- that will EOS
13 me back -- I'll be home.

14 PATRICIA: All right. That's okay right there.

15 MR. HARRIS: Yeah. But I got -- I got to wait until
16 I get done doing what I need to do in August or
17 September, and then she's gonna put the motion in. So
18 everything is great.

19 PATRICIA: Oh.

20 MR. HARRIS: She said everything is great. She said
21 she talked to the State. That's all I was worried
22 about. That's why I kept trying to call, you know, to
23 see what they were saying, to see if they agree. They
24 agreed with her, so everything -- everything great.

25 PATRICIA: That's good. That's good.

1 MR. HARRIS: Yeah. When they agree, that means
2 everything is great.

3 PATRICIA: Yeah. That's good.

4 MR. HARRIS: Yeah. So that's great. That's a
5 blessing. Thank you, Jesus.

6 PATRICIA: Yep. Yep.

7 WAYNE: Hell, yeah.

8 MR. HARRIS: Hell, yeah, that's great, what I said.

9 Anytime them attorneys call the State, the State say
10 yes, we will. They told -- she told me that the State
11 told my attorney yes, we will reduce his time.

12 PATRICIA: Uh-huh. That's good.

13 MR. HARRIS: Once he -- once he do what he have to
14 do, yes, we will agree to reduce his time. She'll have
15 to file a motion and they're going to reduce it.

16 So, you know, I just got to sit back and just chill
17 until them boys trial come up, and they out of there and
18 I'm home.

19 PATRICIA: Yeah.

20 MR. HARRIS: You hear me?

21 Yeah. When I get out this time, boy, I'm going to
22 chill. Boy, I don't want nothing around me. Boy, if it
23 ain't no Harris boy, I don't want none of the boys out
24 there around me, boy.

25 PATRICIA: I know you're right.

1 MR. HARRIS: Period.

2 They come in my yard, they can say hey and keep
3 going. I don't want to talk or straight bull.

4 You hear me, cuz?

5 PATRICIA: That's right.

6 WAYNE: (Inaudible.)

7 MR. HARRIS: That's straight bull with all that. I
8 got to be out there with my family. Man, I got to be
9 out there to protect my family, be out there with my
10 family, man, because I ain't with this bull crap here.
11 You know what I mean? Straight up.

12 WAYNE: Yeah.

13 MR. HARRIS: Real stuff, boy. I ain't even playing.
14 But, you know what I'm saying, I will hit you up
15 for -- you know what I'm talking about? You know what
16 I'm saying? Just see what you can do this week for me,
17 cuz.

18 WAYNE: I fucked up.

19 MR. HARRIS: Oh, you fucked up?

20 WAYNE: I just (inaudible).

21 MR. HARRIS: Oh, okay. You straight, cuz. You
22 ain't got to -- you ain't got to explain nothing. You
23 say you ain't got it, you ain't got it. You feel me?
24 You ain't got it, you ain't got it. You ain't got
25 to -- you know what I'm saying?

1 I know it's locked up right now.

2 WAYNE: (Inaudible.)

3 MR. HARRIS: Huh?

4 WAYNE: Auntie?

5 PATRICIA: I'm here, baby.

6 WAYNE: Why you ain't tell me Keyshia lost --

7 Keyshia lost her job?

8 PATRICIA: Yeah. She didn't want nobody to know it.

9 It was she was trying to make it on her own.

10 WAYNE: She should have been told me she needed some
11 money if she was going to get evicted. She should have
12 called me a week ago.

13 PATRICIA: Yeah. She didn't want nobody to know.

14 (Inaudible.) She hate asking people for stuff.

15 WAYNE: I would like her to call me and ask me. I
16 just laying it down here. I going to drop some money
17 off. I don't want her getting evicted and shit.

18 PATRICIA: Right. Right. I thank you for that.
19 She'll give it back.

20 MR. HARRIS: Oh, he had to look out for Keyshia?

21 WAYNE: I don't like that last minute stuff.

22 PATRICIA: I know you don't. I know you don't.

23 MR. HARRIS: What, you had to look out for Keyshia?
24 How much she ask you for?

25 Man, Keyshia better move back with Momma.

1 PATRICIA: She's supposed to.

2 MR. HARRIS: I don't know why she's doing that and
3 she -- man, she done messed me up for this week, man.

4 PATRICIA: Keyshia like being on her own. It's very
5 hard for someone to move back with someone when they
6 done been on their own for so long.

7 MR. HARRIS: Hey, hey, hey, cuz?

8 WAYNE: Yo.

9 MR. HARRIS: Hey. Check me out. If you -- I
10 understand you helping Keyshia, but just, if you could,
11 bring grandma like \$20 put on my phone, man.

12 WAYNE: Hell, yeah.

13 MR. HARRIS: You heard me?

14 WAYNE: That's just about what I got on me.

15 MR. HARRIS: Yeah.

16 WAYNE: I ain't got shit right now.

17 MR. HARRIS: Yeah. Yeah.

18 (Multiple people talking at once.)

19 MR. HARRIS: Yeah. But all that -- everything is
20 going well with the court stuff, man. I just got to
21 wait and sit back, man. That's all I got to worry
22 about. As long as they gave her that consent.

23 Mom, what you was going to say?

24 PATRICIA: I ain't say nothing, baby.

25 MR. HARRIS: I was trying to, you know what I'm

1 saying have him put something on my phone. You know
2 what I'm saying? That's all.

3 PATRICIA: Uh-huh.

4 MR. HARRIS: Yeah. Because I'm going to be here
5 until Thursday. They'll probably send me back to prison
6 Thursday, but I want to make sure I got a little
7 something on my phone in case I have to call you all.

8 PATRICIA: Right. Right. Right. But I think you
9 do you got some at prison. I don't know.

10 MR. HARRIS: Yeah. I got some up the road. I'm
11 talking about here.

12 PATRICIA: Oh, over there.

13 MR. HARRIS: Yeah. Because these deputies be
14 tripping sometimes and I can get on the phone and call
15 and let you all know what's going on. I gotta have a
16 little something on my phone.

17 WAYNE: Where they sending you?

18 MR. HARRIS: Huh? They're sending me back CFRC

18 WAYNE: All right. Be careful.

19 PATRICIA: All right. All right.

20 MR. HARRIS: All right, boy. I love you.

21 PATRICIA: Bye Wayne-Wayne.

22 WAYNE: Bye, Auntie.

23 MR. HARRIS: Hey, Momma? Ma?

24 PATRICIA: Tony.

25 Mr. HARRIS: All right. Call this number right

1 here, (813)918 --

2 PATRICIA: Whoops. Okay. Wait a minute now. I
3 ain't got my book with me with all the numbers in it.

4 MR. HARRIS: Man, the time of -- you all make
5 this --

6 MR. HARRIS: Hey. What's up, Mom? I'm back -- I'm
7 back at Pasco County Jail to get my -- to get my time
8 reduced.

9 KEYSHIA: Oh-oh. I think the phone is going to go
10 dead.

11 PATRICIA: You back -- you back at Twin Lakes (sic).

12 MR. HARRIS: Yeah. I'm back at Land O' Lakes.

13 PATRICIA: Oh.

14 MR. HARRIS: Yeah. I'm back at Land O' Lakes.

15 I done talked to me attorney. She coming down here
16 to see me this week. She said they agreed and
17 everything. I have to wait until this is over this and
18 then they -- she said they're either going to, you know
19 what I'm saying, let me go or just drop the time.

20 PATRICIA: Oh.

21 MR. HARRIS: You heard me?

22 PATRICIA: Yeah. I heard you. That's what I like.

23 MR. HARRIS: Yeah. All right. You want me to let
24 you go back to sleep?

14 CeCe: Well, they tired of hot dogs and hamburgers.

15 KEYSHIA: Well, I ain't gonna cook nothing.

16 CeCe: Well, I'm cooking up some barbeque chicken
17 right now.

18 KEYSHIA: Their going to eat some noodles or
19 something.

20 MR. HARRIS: Yeah. She said she's cooking up some
21 chicken. Stop doing that to them boys.

22 KEYSHIA: Well, that's good then.

23 MR. HARRIS: All she going to do is try --

24 KEYSHIA: I got to go to work in four hours.

25 MR. HARRIS: All you going to do is try to eat you

1 some chicken too.

2 KEYSHIA: No, I ain't because I don't want no
3 barbeque chicken. I'm going to make me some noodles my
4 darn self.

5 MR. HARRIS: Oh. When the last time you talked to
6 Tricia?

7 KEYSHIA: I haven't talked to Tricia in a while.

8 MR. HARRIS: Oh. All right, you all, they ain't
9 messing with me yet. They letting me talk so.

10 KEYSHIA: I'm surprised.

11 MR. HARRIS: Man, you crazy.

12 Hey, Grandma?

13 Grandma?

14 Oh, grandma?

15 CAROLYN: Yeah, Tony. Yeah.

16 MR. HARRIS: What's you doing?

17 CAROLYN: Yeah, Tony.

18 MR. HARRIS: Oh. Grandma, call Wayne-Wayne.

19 CAROLYN: Hold on.

20 MR. HARRIS: Keyshia, you said the phone about to go
21 off?

22 KEYSHIA: It's beeping.

23 MR. HARRIS: It still beeping?

24 KEYSHIA: It keep doing off and on.

25 MR. HARRIS: When I get off the phone, put it on the

1 charger. You heard me?

2 KEYSHIA: Okay.

3 MR. HARRIS: Yeah. I be talking to little Johnny
4 since I been on the road. I be calling him.

5 CAROLYN: I'm trying to hang on and call Wayne.

6 MR. HARRIS: Go ahead.

7 You heard me, Keyshia?

8 KEYSHIA: You said you been talking to Little
9 Johnny?

10 MR. HARRIS: Yeah. He be -- he said he going to
11 bring some more money to Grandma to send to me.

12 KEYSHIA: Oh. How he been doing?

19 PATRICIA: Okay. Give me the number. I gotta go.

20 MR. HARRIS: You gonna go.

21 PATRICIA: Yeah. I gotta go. I got to go all the
22 way to Tampa to my pain management doctor.

23 MR. HARRIS: Okay. Put Grandma back on the phone.
24 I love you.

25 PATRICIA: Okay. All right. I love you, too.

1 Ma, I got to go.

2 Here. Tony needs you to still do something.

3 CAROLYN: No. Tell Tony I'm busy.

4 MR. HARRIS: Man, Grandma ain't busy.

5 PATRICIA: She is busy. She's looking at some
6 papers -- she got to find out where -- she got to go to
7 the doctor today too, Baby.

8 MR. HARRIS: Oh, okay. All right. Well, check me
9 out. Before you go, call this number right here and

7 FEMALE SPEAKER: Your name, please?

8 MR. HARRIS: Tell him Anthony Harris.

9 FEMALE SPEAKER: Okay. One moment.

10 MR. HARRIS: Hey, Momma?

11 Hey, Mom?

12 PATRICIA: Yeah.

13 MR. HARRIS: Tell Grandma I'm going to call her back
14 in 20 minutes. Don't hang up the phone though.


