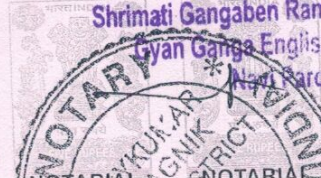

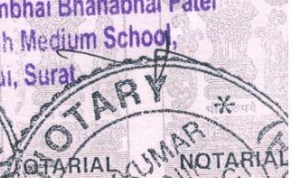

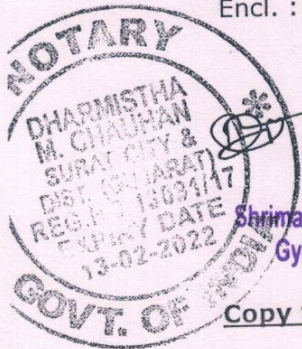

As per meeting dated 13,14,15/06/2017 of Executive Committee from June 2017 in relation to registration of School and as per decision in the meeting dated 17.06.2017, this is to inform you that as per Gujarat Secondary and Higher Secondary Education Act 1972 (Year 1973's Gujarat Act No.18 and year 2002's Gujarat Act-14) and the Secondary Education rules-1974 and in relation to it Government resolutions/Board circulars provisions and as per rules and regulations, your above stated New Secondary (Std.9) Gyan Ganga English Medium School, at & Post Navi Pardi, Opp.Kamrej Sugar Factory, Sumul Dairy Road, Ta.Kamrej, Dist:Surat is registered from June 2017 on permanent basis with a condition not to take grant as anew school. In your school, permission is granted to continue Std.9th

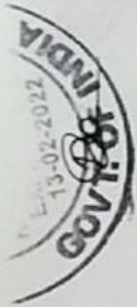
first one class be continued. In your school the medium of education shall be in English and Stream Shall be general. You have to comply with the following conditions. Whenever it come to the knowledge about breach of any condition, then Board as per Section-9(A) proceedings shall be done and registration the school shall be cancelled.

CONDITIONS:

1. Board should be satisfied that the Management of the School is competent and authentic and its administration is managed by Manager formed by proper method and is economically wealthy.
2. Board officer or Board authorized person and Education Department's Supervisor/Officer shall be permitted to do supervision of the school.
3. The School shall have as per standards mentioned in the regulations and Circulars having necessary facility building, furniture, laboratory, equipment, stationery and other things and as per qualifications mentioned in the regulations educational and non-educational staff shall be appointed s per rules. Further for the students sufficient health related facilities shall be established by the School.
 - (A) If the school is fundamental school then the education shall be provided as suggested in the table and provision shall be made relating to industry, land, water, workshop, Industry hall etc.
 - (B) The fundamental school shall have to make arrangement for hostel.
4. The Board should be ensuring that education provided in the school shall be satisfactory in all manner.
5. The School shall have to use the Syllabus recognized by the Government and time to time approved books.
6. As per the conditions prescribed by the board in different standard admission shall be provided to the students.
7. To promote the school students from one standard to higher standard, the promotions shall be as per the standards as decided by the board for the exams for the students.
8. The rates of education fee and the salary of educational and non -educational employees salary shall be government recognized.
9. The schools' records and registers as prescribed by the board shall be prepared with necessary details and shall be maintained.
10. The records as provided by School Principal or Management shall be statistical and honest and authentic.
11. In the school as per regulation 20 qualification as per ratio on receipt of letter within one month appointment should be completed and such employee, during Board's public examination whenever called for any work then they should have to remain present on duty.
12. The board should be satisfied that the prescribed rules relating to discipline by board shall be complied with by employees and students of the school satisfactorily.



13. The management of the school shall have to give assurance that in the school building any class, tuition classes of unrecognized school are not running.
14. The exams taken by board paikee in any one exam cleared by any candidate shall not be prepared for the repetition for the same exam and shall not send.
15. The school shall not refuse to give admission due to only reason of religion, caste, language or such type of any reason.
16. Without prior approval of Board or District Education officer authorized by board in School new standard or additional class shall not be increased or decreased.
17. For more information about staff recruitment guidance of your District Education officer shall be obtained and shall be implemented accordingly.
18. Pursuance to the School proper building and other facilities shall be arranged within one month from this order for which board and your District education officer should be informed.
19. Salary of the school employee shall be done every month regularly by withdrawing money from school account and as per Government rules and regulations through the bank in account of the employee.
20. All the records of the school should be made available with the principal of the school.
21. If certificates and evidences are obtained from outside University, organization then such type of certificates shall be verified by the board of the school by personally visiting respective university and organization and for which school board shall be held responsible.
22. As per the judgment of Hon'ble Supreme Court of India in Civil Petition No. 483/2004 dated 13.4.09 for the safety of the school the School building, fire safety for which guidelines are given and as per it for the safety of students necessary school safety, fire safety etc. available steps shall be taken and for this concerned Authority/Officer as per rules approval shall be obtained and by taking careful steps, and approvals required to be obtained timely and inspection etc. shall be completed in prescribed limit and certificates and approval shall be obtained failing which the school board /school shall be initiated legally.
23. Government's order dated 3.7.93 bearing no. BSS/1093/1322/ch the conditions mentioned therein shall be complied with.
24. The conditions mentioned in the resolution of Education Department bearing No.BSS-1111-1173-C dated 1.7.2011 for deciding non donated private Secondary/Higher Secondary school's for deciding managerial policy.
25. The facility of CCTV camera recording shall be made available and assurance shall be given to District Education Officer for the same .
26. The School Board shall have to provide admission in Class to the students as per regulation 9(13)(3).
27. The school board should not insist students/parents to buy certain types of books, literature, uniform or shoes from their organization or from certain organization or agency of certain brand or company.



28. Gujarat Self dependent School fee Control Act 2017's provisions and the rules made there under shall be applicable to this school and an indemnity bond for its compliance shall be produced.

Your school board, to commence this school the approval vide this office reference letter-4 is granted. As per the said letter, the said school is commenced from June 2017. Considering this fact the registration of the said school is done Before obtaining this registration letter or later if the school is closed or shall be closed then this registration letter shall be automatically cancelled and in next year for the school new application shall be made.

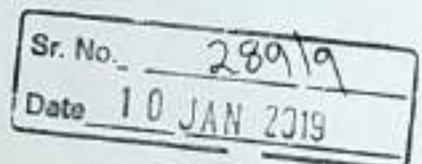
