
India's economic landscape is defined by 6.3 crore enterprises.

6.3 Crore

An estimated 63 million Micro, Small, and Medium Enterprises (MSMEs) form the bedrock of the Indian economy.

Recent momentum is strong, with over 4 crore enterprises formally registered under the Udyam portal alone by late 2024/early 2025.

The Six Core Obstacles to MSME Growth



Limited Access to Formal Finance

Only a fraction of MSMEs secure formal credit due to collateral requirements and perceived risk.



Cashflow Crunch & Delayed Payments

Working capital is strained by persistent payment delays from large buyers.



Regulatory & Compliance Burden

Complex rules and high administrative costs create significant operational friction.



High Informality

A large share operate outside the formal system, restricting access to credit and markets.



Infrastructure & Operational Gaps

Poor logistics and inconsistent utilities weaken competitiveness.



Skill & Technology Deficits

A lack of access to modern systems, talent, and strategic processes required for scale.


