## **INTERNAL COMMISSION SHARING & NON-CIRCUMVENTION AGREEMENT**

This Internal Commission Sharing Agreement (the "Agreement") is entered into and made effective as of the date of execution below, by and between

1. RED ZORIX OIL TRADING LLC, a formal energy trading company duly organized and operating under the laws of Dubai, UAE, located at Dubai, hereinafter referred to as the "Company

2. INDEPENDENT BROKER/AGENT: holding Passport No: \_\_\_\_\_,  
hereinafter referred to as the "Broker

### 1. PURPOSE & SCOPE OF UMBRELLA COVERAGE

The Company hereby grants the Broker the privilege to introduce buyers or sellers of petroleum products under the corporate umbrella, professional reputation, and commercial channels of Red Zorix Oil Trading LLC Every legitimate trade deal brought forward by the Broker will be allocated a specific Transaction Reference Code to ensure meticulous tracking and legal protection of the Broker's position

### 2. 50/50 COMMISSION SPLIT & SUCCESS-BASED CONDITIONS

It is mutually agreed that any and all net commissions, fee protection margins, or brokerage profits generated from transactions successfully facilitated by the Broker shall be split exactly 50% to the Company and 50% to the Broker

This payment structure is strictly success-based and will be executed only after the total transaction target funds have cleared completely inside the Company's corporate banking accounts in Dubai

### 3. NON-CIRCUMVENTION & NON-DISCLOSURE (NCND)

The Company legally binds itself not to circumvent, bypass, or directly finalize deals with the buyers or sellers introduced by the Broker without the Broker's written knowledge and inclusion. Conversely, the Broker agrees to keep all corporate formats, internal pricing strategies, and client data strictly confidential and shall not exploit the Company's corporate identity for independent outside transactions

### 4. COMPLIANCE, BANKING, AND ANTI-MONEY LAUNDERING (AML)

All banking transfers and commission payouts will strictly follow the central banking compliance guidelines of the UAE.

Payouts to the Broker will be processed via Secure Bank Wire Transfer to the verified bank account matching the Broker's provided passport or legal business profile. Cash payments or unverified third-party transfers are strictly prohibited.
