## April 10, 2024 Minutes

Meeting called to order by Chairman Wegand at 5:00pm, present was Clerk Swedberg, Supervisor Flick and Treasurer Mattioli. Supervisor Coenen was absent. Pledge of allegiance was held.

Flick made a motion the agenda, seconded by Wegand, 2 ayes, 0 nays, motion carried.

**Public Comment** – Karen Diedrick questioned about fixing Kelso Rd. Chairman is working with the City on possibly fixing it. The road is split, half city and half town. The most economical repair is a grader patch.

Motion by Flick to approve last month's minutes, seconded by Wegand, 2 ayes, 0 nays, motion carried.

**Fire & EMS Chiefs Report** – Chief Simon questioned about getting a backup power at the station especially during storms like we had recently.

Deputy advised beware of scams. A person in Town fell to the scam and gave someone that came to their house \$9000 in cash.

- **Appoint New Building Inspector** – Chairman and Clerk met with Ryan, possible new building inspector. He would charge 90/10 on all permits, as well as \$100 per month. He does Village of Greenville and Commercial for City of Kaukauna. Motion by Flick to issue 30 termination notice to Paul Hermes, seconded by Wegand, 2 ayes, 0 nays, motion carried. Motion by Wegand to appoint RG Inspections LLC, Ryan Geiger as building, seconded by Flick, 2 ayes, 0 nays, motion carried.
- **VanHandel Estates Culvert Issues** – There are multiple issues with people exceeding the width ordinance. There are also multiple properties that have concrete up to the road. This is against the ordinance and they will be required to pay for any damages caused to plows, etc. Motion by Flick to send letters to N2143 Bitternut and N2240 Cotton Tail reminding of the 30ft ordinance, letter to N2193 Cotton Tail advising they are over the 30 ft ordinance and they need to fix or apply for a variance, seconded by Wegand, 2 ayes, 0 nays, motion carried.
- **Stoneyard Operators License** – Motion by Flick to approve an operator's license to Kenneth Finn and Naveah Snyder, seconded Wegand, 3 ayes, 0 nays, motion carried.
