Call to Order: Chairman Wegand called the meeting to order at 5:00pm.

Roll Call:

Consent Agenda

- **Approval of Minutes**
- **Fire Chiefs Report** – One firefighter completed school, one firefighter started last week and two interviews next week. One call for the year so far. One firefighter has resigned. The new engine ready for pickup date is March 16 at this time.
- **EMS Chiefs Report** – 93 calls last year, up from 78 last year or about 20%. Down 2 first responders as they moved out of the towns. 5 calls so far this year. The switch to Kaukauna Ambulance is making a difference.

Old Business

New Business

- **Fire Chief Approval** – Fire Chief Shawn Simon was reelected by the firefighters for another 2-year term subject to Town Board approval. Motion by Coenen to approve Shaun Simon for fire chief for 2 years, seconded by Flick, 3 ayes, 0 nays, motion carried.
- **EMS Chief Approval** – Cory Swedberg was elected by the first responders for EMS Chief to replace Shane Robley who is stepping down. This is a 2-year term subject to Town Board approval. Motion by Coenen to approve Cory Swedberg for EMS chief for 2 years, seconded by Flick, 3 ayes, 0 nays, motion carried.
- **CSM North Kaukauna Storage** – Motion by Flick to approve CSM as presented, seconded by Coenen, 3 ayes, 0 nays, motion carried.
- **CD Renewals** – Fire Surplus CD will mature on 02/24/26 – this will need to be pulled out to pay for the new truck. The Town Surplus CD will mature on 01/26/26. The bank provided rates of 3.75% for 6 months or 3.60% for 12 months. Motion by Wegand to renew the Town Surplus for 12 months at 3.6%, seconded by Coenen, 3 ayes, 0 nays, motion carried.
- **Double Door Estimate – Town Hall** – Estimate from JM Renovations to change the door for the storage room from a single to a double door for \$4712.18. Motion by Flick to approve the estimate as presented, seconded by Coenen, 3 ayes, 0 nays, motion carried.
- **Truck Financing Update** – The state advised that if we pull the money out before March 15, 2026, we will have to make two payments instead of the three as planned, if we wait until after, then it would be three payments. Another option is to cancel the loan and reapply for a 4-year term and then we can pull out the funds before March 15. As of now, Ready Date from Pierce is March 16, 2026. Will wait until after March 15, 2026 to request the funds.

Correspondence: Chairman Wegand advised that he was contacted by Outagamie Highway and advised they are running low on salt, going forward for this year, they will be using a sand/salt mixture.
