You can pay your balance online by logging into your account with a credit card, or by calling the Camp Office and paying over the phone. If you prefer to mail your payment, you can pay your remaining balance by Money Order, made payable to Summer Camps at College Settlement.

Final payments and paperwork must be received four weeks before your child's session start date. Failure to submit final paperwork and payment on time will result in your child being dropped from enrollment and losing their space. If you need help paying your balance, call the Camp Office to request a Scholarship Form. This must be done **before** your payment deadline date.

2022 Refund & Cancellation Policy

- 1. Final payments and paperwork must be received four weeks before your child's session start date.
- 2. Failure to submit final paperwork and payment on time will result in your child being dropped from enrollment and losing their space.
- 3. Cancellations must be communicated to the Camp Office at least two weeks before your chosen session. You will receive a refund of any Camp tuition paid.
- 4. No refunds will be issued if your child is dismissed due to a violation of the Camper Code of Conduct. The Summer Camps at College Settlement retain the right to dismiss any camper if deemed necessary.
- 5. Prorated refunds are available to campers who depart their session early for medical reasons. In this instance, refunds of Camp payments will be prorated for the days attended, minus the Registration Deposit.
- 6. If your child has been exposed to someone with Covid-19 or tests positive for Covid-19, do not send them to Camp. Please notify the Camp Office and we will inform you of the protocols necessary. If you can provide a positive test result to the Camp Office, you will be refunded on a prorated basis, or offered enrollment in another session (space permitting).
- 7. If your child becomes sick before arriving at Camp and is unable to attend the scheduled weeks, or has a temperature and cannot attend, please contact the Camp Office and we will attempt to reschedule your session.
- 8. If you paid by credit card, it takes 1-2 weeks from the date requested to receive a refund on your credit card statement.
- 9. If an entire Camp session is cancelled by College Settlement due to health / safety concerns, Parents & Guardians will be notified as soon as possible and will then receive a full refund of any Camp tuition paid.
