Notice is hereby given that a regular meeting of the Board of Commissioners of Ellis County Emergency Services District No. 10 will be held on Monday, June 8, 2026, at 6:30 p.m., at the Bardwell Area Fire Department, located at 506 E. Sycamore Street, Bardwell, Texas 75101, for the following purposes:

4. Public Comment: Individual members of the public may address the Board for a maximum of three minutes on items not on the current agenda. In accordance with the Texas Open Meetings Act, any response to a public comment on items not on the published final agenda will be limited to a statement of factual information or a statement of existing policy. Any deliberation or decision by the Board will be limited to a proposal to place the subject on a future agenda. Members of the public may collectively address the Board for a total of thirty minutes on items not on the current agenda.
5. Public Comment on agenda items: Individual members of the public may speak on an agenda item after comments on the item are called for by the presiding officer for a maximum of three minutes. Individuals may address the Board once per item. Members of the public may collectively address the Board for a total of thirty minutes per agenda item. The thirty minutes will not include time spent by individuals responding to questions by the Board.

9. Receive report from General Counsel, including, but not limited to, tax matters, pending contract issues, open records request, and other legal issues, if any, and take any related action;


