***2 What is an Open Youth entrant?**

1. **Must be 5 to 9 years of age as of Friday of the Fair** – i.e. born on or between **Jan 1st, 2012 and Sept 24th, 2016**.
 - a. Someone who is 5 years old or older as of Sept 24, 2021 (Friday of the Fair)
 - b. Someone who has NOT turned 9 years old as of the previous Dec 31st *(if they have turned 9 by the previous Dec 31 they can participate in the Ag Expo as a 4-H Junior member through their respective 4-H Club.)*
2. A contributor unable to handle his/her own lamb will automatically be put in an open class. If there is a youth contributor that is younger than 5 years of age (born after Sept 24, 2015) they can compete in the Open Class with the help of their parent/guardian.
3. All Open Youth entrants will be entered in the Open Youth showmanship class, either by their Open Youth Market entry (which must be sold on Monday) or by their Open Youth Showmanship Female entry (which does not have to be sold).
