CIVILIAN MARKSMANSHIP PROGRAM MATCH REPORT

We had our last 2018 season match on the 8th of December 2018. Chris Jen drove all the way up from Salinas to take a silver pin in the Modern Military category with a score of 277-3X. There were several competitors using M-1's and one using a Springfield '03 with cast bullets. The weather cooperated by being warm even though it was cloudy.



The year 2019 will be our tenth year holding CMP matches in the 21st Centu-

ry. Looking into Lincoln Rifle Club history, it appears there were some Director of Civilian Marksmanship (DCM) matches, which were the forerunner of the CMP matches held at Dillman Range in the early 1960's. The DCM was an organization ran by the U.S. Army under government regulations. It was usually commanded by a full colonel and had a mission to make sure there were an adequate number of trained civilian marksmen on hand in the event of war. The DCM was started by Theodore Roosevelt in 1903. Politics being what they are, some politicians thought teaching people how to safely shoot and compete with firearms was a bad, costly thing, so they voted out this government run program. A group of enterprising shooters formed a corporation using the old government regulations and called it The Civilian Marksmanship Program.

For 2019, we have the following dates scheduled for matches: 12 January, 9 February, 9 March, 13 April, 8 June, 14 September, 12 October, 9 November, 14 December. These dates are on the second Saturday of their respective months. We start assigning shooting positions at 0730AM and start shooting at 0800AM. Cost to enter the match is \$15.00 and the shooter should bring a minimum of 35 rounds of ammunition which is chambered for the rifle being used. The course of fire is The John C. Garand Course "A"; as follows 5 sighting shots in 5 mins., 10 shots prone slow fire in 10 mins., 10 shots prone rapid fire in 80 seconds (if a bolt rifle is on the line, 70 seconds if all are semi-autos), and 10 shots offhand (standing) position in 10 mins. Targets are SR-1, 100 yard military rifle.

For M-1 or Springfield competitors, the club sells 30-06 surplus ammo FOR USE DURING THE MATCH ONLY at a cost of \$15/20rds for old Frankfort Arsenal M-1 and \$17.50/20rds for newer CMP issue.

CONVENTIONAL PISTOL MATCH REPORT

Our indoor Conventional Pistol match is once again up and running for the winter. With it being cold, wet, foggy and windy at the outdoor range you might consider coming over to the Indoor Range on the second and fourth Wednesday of each month until the end of April.

Each match relay is about one hour long during which we shoot at NRA B-2 and NRA B-3 targets at 50 feet using .22LR caliber pistols or revolvers equipped with either iron sights or electronic sights; no laser sights permitted. Shooters can choose to shoot either one hand standing or two hand standing ("F" class). Scores are maintained in separate classes.

The course of fire is 5 rounds sighters, 10 rounds in ten minutes slow fire 2 times. 5 rounds in 20 seconds timed fire four times. Then 5 rounds in 10 seconds rapid fire four times. Then we score each others' targets.



All you need to participate is a pistol or revolver chambered for .22LR, eye and ear protection, 65 rounds of ammo, and a desire to have fun. You will be joining the ranks of some of the best pistol shooters in the Club. Any doubt, just ask them. We all know that shooters always tell the truth when bragging, right?

The Indoor Range opens at 3:30 for registration and set up for the Match. First Relay is at 5:00PM and the second relay is at 6:30 PM. Cost is \$10.00 Club match registration and then \$5.00 each night for the match. Come join us for a really good time!!

Shooting Your first Pistol Match; Stepping Past the Static Line By Arnold Chin, Match Director Multi-Gun Division (MGD) Happy New Year from Multi-Gun Division Over recent months, I've had the opportunity to meet fellow LRC members who have expressed an interest in participating in our matches. Many are CCW holders looking to sharpen their skills, while others are looking to do more than shooting on the static line. Known as, "Practical shooting", our monthly pistol matches offer a good medium to practice drawing from a holster, moving, reloading, and shooting from various positions. You are timed under direct supervision of a range officer. Unlike static line shooting on the public range, double-tapping a target is allowed. So, what is holding you back? The most common response is the perception of pressure associated with competition. It is a common feeling that new shooters are worried that everyone is watching them, or that they may not prove to be a very good shooter. It is true that the idea of shooting in a competition doesn't necessarily lend itself to welcoming environment. In truth, the reality is that no one will care if you are fast, slow, accurate, or not. No one will care if you shoot a Glock, Springfield, CZ, etc. What we do care about, first and foremost, is that you are exercising safe practices in the handling your firearm. Shoot slow, take a make-up shot, perform a standing reload, and walk to the next shooting position. We eagerly want to see safe practices over flashy speed. You can expect to meet people who are willing to

help you through your match, walk stages with you, give you some helpful tips, and answer any questions. YOUR first step will be to take the "Intro to USPSA" safety course to learn about our specific safety practices and shooter expectations. Consumer Alert Regarding the Use of "Federal Limits Apply" Driver Licenses and Identification Cards to Purchase Firearms



If you have a "FEDERAL LIMITS APPLY" driver license or identification card and wish to use it as identification to purchase a firearm, the dealer might require you to present proof that you are lawfully present in the United States. This is because federal law prohibits anyone who is not lawfully present in the United States from receiving or possessing a firearm or ammunition.

The Department of Motor Vehicles (DMV) currently issues two types of California driver licenses and identification cards: "REAL ID" and "FEDERAL LIMITS APPLY" (samples below). An applicant for a "FEDERAL LIMITS APPLY" driver license or identification card is not necessarily required to provide proof to DMV of lawful presence in the country.

Recently enacted state legislation (Cal. Stats. 2018, ch. 885, S.B. 244) prohibits certain "FEDERAL LIMITS APPLY" driver licenses and identification cards—those issued to persons who were not required to submit satisfactory proof of lawful presence in the United States—from being used as evidence of an individual's citizenship or immigration status for any purpose. These driver licenses and identification cards are physically indistinguishable from other "FEDERAL LIMITS APPLY" driver licenses and identification cards issued to individuals who have provided satisfactory proof of lawful presence in the United States.

The California Department of Justice has advised firearms dealers that they may wish to consider requiring proof of lawful presence from all purchasers who present a "FEDERAL LIMITS APPLY" driver license or identification card. If you plan to purchase a firearm using a "FEDERAL LIMITS APPLY" driver license or identification card, the dealer might also require you to present one of the following documents:

Valid, unexpired U.S. passport or passport card
Certified copy of U.S. birth certificate
U.S. Certificate or Consular Report of Birth Abroad of a U.S. Citizen
Valid, unexpired foreign passport with valid U.S. immigrant visa and approved Record of Arrival/Departure (I-94) form

Certified copy of birth certificate from a U.S. Territory Certificate of Naturalization or U.S. Citizenship Valid, unexpired Permanent Resident Card

To avoid surprises, you should check with the firearms dealer you plan to visit to verify the dealer's identification requirements. Alternatively, you can obtain a RE-AL ID driver license or identification card, which would provide sufficient proof of lawful presence in the United States. **Please note that beginning October 1**, **2020, the federal government will require your driver license or identifica-tion card to be a REAL ID if you wish to use it as identification to board a**



domestic flight or enter military bases and most federal facilities. Information about REAL ID licenses and identification cards can be obtained from the DMV at www.dmv.ca.gov.

A DAY IN HISTORY—JANUARY 1, 1863

On January 1, 1863, Abraham Lincoln signed the Emancipation Proclamation, which declared all slaves in Confederate territory to be free. The proclamation stated that, as of that day, "all persons held as slaves within any State or designated part of a State...in rebellion against the United States, shall be then, thenceforward, and forever free."

Lincoln signed the proclamation in his office on New Year's Day afternoon. Several cabinet members and other officials joined him for the historic occasion. The president dipped a gold pen in ink but then put it down because his hand was trembling. He'd been shaking hands for hours at a reception, he explained, and his arm felt "almost paralyzed." He worried that a shaky signature might prompt critics to claim that he hesitated. "I never, in my life, felt more certain that I was doing right than I do in signing this paper," he told those looking on. Flexing his arm and taking up

the pen again, he carefully wrote his name. Lincoln signed most government documents as *A. Lincoln.* For the Emancipation Proclamation, he wrote his name in full. "That will do," he said,



looking up and smiling.

With the passing of time, the text of the original Emancipation Proclamation has faded, and its paper has yellowed. But the signature of Abraham Lincoln stands forth bold, bright, and clear.
