The purpose of this paperwork is to notify the appropriate agencies to keep on record that I am a breathing man with a soul, living upon the land and attach an Affidavit of Life with a sample blood DNA for your records.

It has come to my attention that the name I have known to be my surname is in fact not who I am nor factual Identity. I was only given one name and the surname was usurped upon me and my mother and father for lack of education by the Corporate authorities.

Through social, political and cultural upbringing, presumptions and assumptions, through both the State I was born in and the United Kingdom Corporation, through fraud of the States withholding vital information, preventing the true education of the matter of fact. My mother and father accepted the very documentation that would enslave me throughout my life, thus attaching and implying adhesion contracts accepting the surname as my name.

Further to this, an attached ID number and attached Citizenship number was provided by the Secretary of State in 2005. Extensive research has shown that these numbers were created for the purpose of using them with the Security and Exchange Commission as a CUSIP numbers to create a legal entity, CUSIP stands for Committee on Uniform Security Identification, a 9 - digit alphanumeric code.

This is created for the purpose of hypothecating the bond attached and allowing for penalties and fines on the man/ woman who carries and accepts the name as his/ her own. The creation of the commercial legal person and entity who functions with is attached to the living breathing flesh and blood man/ woman who mistakenly believed that the name in capitals or the surname preceded with Title such as Mr are one and the same as the family or House name. The birth and Naturalization certificates provided to my family and myself are in fact bond documentation.

The History and extent of the of the slave trade is much older and wider than has been taught to the public.

A timeline of historical events researched has pointed in the direction that I am considered legally either missing or dead, based upon the Cestui Que Vie Act of 1666 and I write to set the record straight as it is my duty in law, otherwise my silence would deem consent and acquiescence to carry on in this manner.

Contrary to society's beliefs today engineered by the education, political and media, slavery was never abolished, but was simply replaced globally with "civil

rights and privileges". Slave owners were compensated for loss of their property (ie slaves) and a conveyance of ownership took place. Instead, these slaves became property of the State and the system of Registration became global and enshrined later on in the United Nations Article 7 and 8 of the Convention on the Rights of the Child declaring that national governments **must** (a synonym to 'may') register children immediately after birth, thus open to interpretation. I believe by social, political and economic engineering that people were tricked into believing the birth certificate represents the people and not persons, the dead entity and legal person. Governments never disclosed to anyone of the existence of the Cestui Que Vie Act and development of Birth Registration neither can it repeal it as it was not part of its creation, and today takes on the for - profit Corporate Status that can only function with other Corporate legal persons under contractual agreements. It is not working for the benefit of the people and cannot repeal the Cestui Que Vie Act 1666 even if its executives wanted.

One of the problems the Act possesses is, that although it encourages those who are alive to come forward and declare themselves so, the authors did not provide any specific protocols or acceptable instruction with which to do so, as through the global evolved system of registration and interconnected Corporate Treaties and Corporate structures still render us all slaves, chattel and vessels under maritime law.

I therefore find myself in a position where I must find and create my own remedy, since one was never produced by the authorities of the time.

In light of the above I Dani of the House of Gan, the living, breathing flesh and blood man declare myself having been found alive and living and correct the errors, as to keep silent would deem my acquiescence. It is my legal and moral duty to correct the errors in writing as to prevent others from being mis-lead of my status, standing and Jurisdiction.

The United Nations have Treaties and Agreements between Member States and are enforceable to them. They are not enforceable on the people as they

were not party to these Treaties. It is for this reason that the following still applies: Article 1 of the International Covenant on Civil and Political Rights (ICCPR) and article 1 of the International Covenant on Economic Social and Cultural Rights (ICESCR) both express the right of all **peoples** to self - determination, The ICCPR and the ICESCR go on to say that "By virtue of that right they [the people] freely determine their political status and freely pursue their economic, social and cultural development." The ICCPR and the ICESCR was adopted in 1966 and ratified in 1976.

In 1666 Cestui Que Vie Act was provided as remedy for those who's status is regarded as lost beyond the sea. Regardless of the literal meaning of "sea" Since this Act came into force all persons have been plundered into a life of Maritime and Merchant Law as they are regarded as vessels lost beyond the sea. And while it is my right to decide of my own status, I have the right to declare myself having been born and found alive and still living 41 years later and to acquire the status of being free and not lost beyond the sea nor be considered a dead entity or legal person

By virtue of the right to self-determination as expressed in the ICCPR and the ICESCR enforced and ratified by the UK in 1976, this shall serve as notice to certify that I; A Living Soul, so called by my Mother and Father since born, Dani of the lineage Gan Affirm that I am a Private and Free man, described by the Lord God in Genesis 2:7 as a Living Soul, existing under God's law and his grace alone. I am among God's people and I have assumed among the Powers of the Earth, granted by the Lord God Almighty, the Separate and Equal Station to which the laws of Nature and Nature's God entitle me, Giving me dominion over all things (Genesis, Chapter 1, verse 27-28).

A copy of this document and Declaration of having been found alive and living bearing 3 witness signatures has been sent to Chief Coroner Thomas Teague and Alison Hewitt Senior Coroner for City of London as well. You will find a copy of the blood DNA above sealing my autograph. I am keeping the original for my records, however the autograph below is sealed with a thumbprint which will match my blood DNA.

Finally, to clarify my Status Standing and Jurisdiction, In 1986 Dr Isaiah Rubinstein while working for the Weizmann Institute of Science discovered that the Sulphuric Bridge [Disulfide Bonds] make sure the DNA remain attached.

These Bonds known as ATCG and were inside each of our body in the following sequence:

Every 10 acids there was a Bridge

Every 5 acids there was a Bridge

Every 6 acids there was a Bridge

Every 5 acids there was a Bridge.
