A GREAT CONCEPT IN AIRCRAFT AVAILABILITY

See application/information sheet

- The *Flying M-Club* is an innovative program to make flying more affordable. Club members receive a \$30.00 discount on the hourly retail aircraft rental rate. **This also means that club members can have access to two different aircraft at club prices, at all times*, receiving *rental-type service at club prices*.** This makes it virtually *guaranteed* that you will have access to an aircraft when you want without worries about scheduling or maintenance issues. This applies to all *M & M Aviation* aircraft in which the member is training or is qualified to fly. Members are charged a base rate for the rental of the aircraft and an additional surcharge for fuel. This surcharge may be adjusted from time to time (up or down) to reflect the rate we must pay for fuel. (Note: as of this date, the total rental rates have not changed from what they have been the last year.)
- It is ideal for pilots who fly for pleasure, or who are working towards a private pilot certificate, or advanced rating. Pilots, who hold a private pilot certificate, an advanced rating or are working towards an advanced rating, may join for a one-time enrollment fee of \$200. Monthly dues are \$30. Students working toward their private pilot certificate join for an enrollment fee of \$300 and monthly dues of \$30.
- Monthly dues payment options:
 - Pay for 12 months in advance at the time of enrollment (\$360 paid by check or cash)
 - Set up an automatic electronic funds transfer of \$30 per month (\$35 if paid via cash, check or credit card, monthly).
- Club members also receive a \$5 per hour discount on the instruction rates charged to customers who own their own aircraft.

- Another option for renters is to purchase time at a “block-rate”. The block rate gives the renter a 10% discount on the rental rate for the base rate. While it does not give the pilot as low a price as a membership rate, it requires no initiation fee or monthly commitment. All block rates must be paid in advance with cash or guaranteed check.
