## SABER Registration and Certification Steps

### 1. Application and Preliminary Inspection

Each product to be shipped to Saudi Arabia meets the technical requirements determined by SASO, based on the relevant GTIP code.

In return, you receive a number from the GOEIC institution. With this number, you can export to all your customers in Egypt using the GOEIC number.





## PERIODIC CHECKS



Periodic inspections have been made mandatory for lifting and conveying machines, pressure vessels, elevators, escalators, moving walkways, machines and benches, scaffolding, fire systems and fire extinguishers, ventilation systems, electrical systems, generators and batteries.



Periodic inspections are critical to ensuring occupational safety. Regular inspections of work equipment ensure that its maintenance is carried out without interruption. These inspections are performed to determine the safe operation of equipment or installations and are carried out in accordance with relevant product standards and regulations.

At HG, our team constantly monitors the current standards and regulations that define inspection criteria and provides our customers with information about these requirements.

**Attention!** To ensure safe and healthy work environments and to protect employees from health and safety risks, the Ministry of Labor and Social Security has enacted various legal regulations, including Occupational Health and Safety Law No. 6331 and the Regulation on Health and Safety Conditions in the Use of Work Equipment. Periodic inspections of facilities, machinery, and equipment used by businesses are mandatory at specific intervals.



## CE CERTIFICATE AND TESTING

The CE marking indicates that a product complies with European Union safety, health, environmental, and consumer protection standards. This marking is considered a type of "product passport" that allows products to circulate freely within the European Union market and is also mandatory in Turkey.

The CE marking is mandatory for certain product groups covered by 29 European Union directives. These groups include various products such as construction materials, elevators, medical devices, toys, and pressure vessels. The CE marking guarantees that the product will not harm human, animal, plant health, or the environment. Therefore, the CE marking both legally protects the manufacturer and ensures the product's market preference.

The CE marking process involves determining a product's compliance with relevant directives, conducting necessary tests, and preparing a declaration of conformity. This marking enhances product reliability, prevents accidents, and prevents legal issues.

### What are the benefits of the CE marking?

- It eliminates the possibility of product delays by granting free movement to the product.
- It ensures product traceability, preventing defective products.
- It prevents product-related accidents and damage.
- It facilitates the marketing phase by ensuring the product's status as a safe product.

## US FDA/CSA



The FDA (U.S. Food and Drug Administration) is a U.S. government agency responsible for the safety of various products, including food, drugs, medical devices, cosmetics, and veterinary products. Founded in 1862, the FDA operates under the U.S. Department of Health and Safety and, with over 10,000 personnel, oversees and approves the safety of products.

FDA certification is a crucial step for products to enter the U.S. market. After the registration process is completed, manufacturers are typically required to provide registration documents or proof of FDA registration. This document ensures the safety of the products and their legal compliance in the market.

FOR FDA REGISTRATION PROCESSES, IT IS ENOUGH TO SUBMIT AN EXCEL FILE WITH PRODUCT IMAGES.

The Canadian Standards Association (CSA), a not-for-profit organization, develops standards and provides training and consulting services in 57 different fields. The CSA mark certifies that a product or service complies with Canadian or US standards, providing brands with international recognition and access to foreign markets. It operates primarily in the energy, construction, life sciences, electrical, and electronics sectors.

Various documents and certifications are used to prove that businesses' production and service processes comply with specific standards, and are crucial for meeting national and international legal and consumer expectations. These documents demonstrate the compliance of your business's processes with these standards.

## RUSSIA EAC/GOST R



The EAC Certificate is an official certificate of conformity valid in the member countries of the Eurasian Economic Union (EEA) that demonstrates the conformity of products to specific technical standards. The term "EAC" stands for "Eurasian Conformity," and this certificate is particularly valid in countries such as Russia, Belarus, Kazakhstan, Kyrgyzstan, and Armenia. This certificate proves that products meet specific quality and safety standards before being sold in the EEA member countries.

The EAC Certificate guarantees that products are safe and will not cause harm to consumers, providing assurance to both the manufacturer and the consumer. In the EEA countries, this certificate is mandatory for certain product categories. The certificate is required for various product groups, including electrical and electronic products, machinery, chemicals, food, agricultural products, automotive, medical devices, and construction materials.

### For Which Categories and Products Should It Be Obtained?

EAC certification is required for a wide range of products. EAC certification requirements vary across various product categories within the Eurasian Economic Union (EAEU). Generally, the product categories requiring EAC certification are:

1. Electrical and Electronic Products
2. Machinery and Equipment
3. Chemical Products
4. Food and Agricultural Products
5. Automotive Products
6. Medical Devices
7. Construction Products

*The Russian GOST-R Certificate is a certificate of conformity confirming that products manufactured or imported into Russia comply with the technical regulations and standards set by the country. This certificate guarantees the safety and quality of products in Russia and is mandatory for these products to be sold on the Russian market.*

*The GOST-R Certificate can apply to various product categories, including electrical appliances, building materials, food products, chemicals, and toys. Products are tested by independent laboratories and approved by certification bodies. The certificate is applied for by the manufacturer or importer and presented to prove that the products meet certain technical requirements. Furthermore, this certificate is regularly monitored and updated to ensure that the products maintain their compliance.*

## HALAL CERTIFICATE

Halal Food Certificates are official documents certifying the halal nature of food products produced and processed in accordance with Islamic principles. These certificates verify that all processes, from production to distribution, comply with Islamic principles.

Halal Food Certificates are crucial for providing Muslim consumers with food that complies with religious requirements. These certificates also enable you to sell your products in markets with a large Muslim population and increase consumer confidence in these markets. Halal certification also provides a competitive advantage in international markets, as demand for halal products is increasing.

### Who Should Obtain a Halal Food Certificate?

- 1. Food Producers:** Businesses that produce food products must obtain a halal food certificate to verify that their products comply with Islamic religious rules. This is especially important for businesses that produce meat, dairy products, and bakery products.
- 2. Restaurants and Food and Beverage Establishments:** Restaurants and food and beverage establishments must obtain a halal food certificate to demonstrate that the food and beverages offered on their menus are halal. This certificate is crucial for businesses that serve Muslim customers.
- 3. Food Importers and Exporters:** Businesses that export or import food products to other countries must obtain Halal Food Certificates to compete in the international market and demonstrate their reliability.
- 4. Food Packaging and Distribution Companies:** Companies that package or distribute food products must obtain Halal Food Certificates to verify that the products are stored and transported in accordance with Islamic religious rules.

Obtaining Halal Food Certificates generally requires applying to an authorized Halal certification body and undergoing inspections under specific rules and audits. This certification process may vary depending on the product type, production processes, and the Halal certification rules of the specific country or region.

## REACH TEST



### What is REACH?

REACH, Regulation No. 1907/2006 of the European Commission, is the European Union's chemical regulation that came into force in June 2007. This regulation aims to protect human health and the environment while also increasing the free movement and competitiveness of chemicals within the EU.

REACH is a comprehensive regulation and covers nearly all commercial products other than food, feed, or pharmaceuticals. Many consumer products, such as clothing, footwear, jewelry, electrical and electronic products, toys, furniture, and health and beauty products, are covered by this regulation. Products already regulated by product-specific regulations may also fall within the scope of REACH. While REACH is a European regulation, non-EU companies with global supply chains may also be required to comply with these requirements.

REACH registration is supported by chemical substance analysis and physical-chemical testing programs, and this process is carried out through the management of (eco)toxicological studies.

REACH testing programs are a crucial part of your REACH registration process. REACH requires manufacturers and importers to collect information on the properties of chemical substances and record this information in a central database managed by the European Chemicals Agency (ECHA).

REACH aims to protect human health and the environment.

## KUWAIT (KUCAS) CERTIFICATE



Kuwait KUCAS System and CoC Document Consultancy | HG International Certification

Companies exporting to Kuwait are required to undergo a conformity assessment under the Kuwait Conformity Assurance Scheme (KUCAS) system and obtain a CoC (Certificate of Conformity) approved by the TIR Authority. This practice, particularly applicable to risky product groups such as electrical products, automotive parts, and toys, is managed by the Kuwait Authority for Standardization and Metrology (PAI). Pre-export certificates of conformity and TIR Authority approval processes are available.

### What is KUCAS and Why is it Important?

KUCAS is a comprehensive conformity verification system that checks products imported into Kuwait for compliance with the country's technical standards and safety criteria before shipment. To avoid potential delays in import procedures, products must be tested and approved.

Exporting companies must work with authorized and accredited organizations to have their products tested under KUCAS and obtain a TIR-approved CoC. The pre-export certificate of conformity and TIR authority approval processes are detailed below.

### KUCAS Conformity Assessment Process and Pricing

The process is typically completed within 7-15 business days.

Prices vary depending on the product type, the scope of the tests, and the number of documents required.

To ensure a smooth and swift process, a preliminary technical assessment is recommended. This includes obtaining a certificate of conformity and TIR authority approval before exporting to Kuwait.

The Kenya Standards Board (KEBS) has launched the Pre-Export Verification of Conformity (PVoC) program to ensure the quality and compliance of imported products with Kenya's health, safety, and environmental standards. Under this program, you must complete the product conformity documentation for exports to Kenya.

### **\*\*Current Requirements:\*\***

- **\*\*Certificate of Conformity (CoC):\*\*** This document is mandatory for products exported to Kenya. The certificate of conformity is required for hygienic customs clearance.
- **\*\*Customs Procedures:\*\*** Passage through hygienic customs without a certificate of conformity is not permitted.
- **\*\*Exemption:\*\*** Even products exempt from the PVoC program are subject to KEBS supervision.
- **\*\*Liability:\*\*** The exporter is responsible for any legal and financial consequences that may arise from synthetics shipped without a certificate of conformity.
- **\*\*Supplier Responsibility:\*\*** Ensuring product conformity is the responsibility of the supplier or exporter.

### **\*\*Key Elements of the PVoC Program:\*\***

- **\*\*Pre-Shipment Inspection:\*\*** Physical inspection of products during shipment.
- **\*\*Sample Testing:\*\*** Tests and analyses performed at accredited laboratories.
- **\*\*Product Processes:\*\*** Control of production processes.
- **\*\*Document Control:\*\*** Control of legal regulations.
- **\*\*Compliance with Standards:\*\*** Evaluation of Kenyan rates.

Kenya's PVoC program ensures that products meet safety, quality, and security standards, contributing to the smooth operation of international trade and preventing delays at customs. This process also reduces potential losses from importing non-compliant products.

## IRAQ INTERTECH INSPECTON



### INTERTEK CERTIFICATE AND PRE-EXPORT CONFORMITY AUDIT REQUIRED FOR IRAQI EXPORTS

This document certifies that products comply with Iraqi health, safety, and quality standards. This compliance inspection, conducted before export, ensures that the products meet specific criteria and comply with Iraqi regulations.

Inspection Procedure:

Inspection: During inspections conducted by Intertek, products are thoroughly inspected.

## NIGERIA SONCAP/PCR



### SONCAP Certification and Export Process

Nigeria has implemented SONCAP (Conformity Assessment Program) to ensure product safety and quality standards.

Under this program,

Two main certificates are required for products exported to Nigeria:

Product Certificate (PC): Confirms that the product is registered or licensed.

SONCAP Certificate (SC): Confirms that the product complies with Nigerian standards.

Why Obtain SONCAP Certification? Issued by the Standards Organization of Nigeria (SON) since 2013, SONCAP certification guides exporters through this process. Obtaining certification allows products to enter Nigeria and manages the compliance audit process.

SONCAP Exempt Products: The following products are excluded from SONCAP:

Food products

Medicines

Medical products excluding equipment and machinery

Chemical products used as raw materials

Military supplies

Goods classified as contraband

Used products (excluding automobiles)

Machinery and spare parts used by "bona fide manufacturers" (must be registered with the Nigerian Manufacturers Association)

Conformity Assessment Process: Cotecna offers physical inspection, sampling, and testing services for Nigeria. The assessment process is conducted via one of three routes, depending on the product type:

Route A: For infrequent shipments (unregistered products).

Route B: For regular shipments (registered products).

Route C: For high-volume shipments (licensed products).
