

Nora was 37 years old the first time she walked through the doors of Pathways Pregnancy Clinic. Nora described her life before her pregnancy as being full of adventure and love - minus a baby.

When Nora was asked how she felt upon hearing she was pregnant, she stated she was "excited and grateful." She went on to describe how "amazing and beautiful" it was to see her baby for the first time during an ultrasound.

Nora used the many services and resources Pathways offers including the Earn While You Learn program. The program is a series of 215 self-paced DVD lessons on multiple topics including the ABC's of pregnancy, child development, parenting topics, and life-skills. With each completed lesson, clients can collect baby bucks, which in turn can be redeemed in the Pathways Boutique for items such as maternity and baby clothing, diapers, baby food, and more.

Nora took full advantage of the program and was enthusiastic about what she could learn from the lessons. Her enthusiasm served her well; she not only worked through the lessons in record time, but she was the first client to utilize Pathways' new car seat incentive program. Nora completed all 60 lessons in the main curriculum pack and her hard work was rewarded with a new car seat.

The car seat and baby items are the kinds of tangible resources Nora received through Pathways, but she also

received some unexpected benefits such as support, love, and encouragement. When asked if she had a message for Pathways' donors, Nora expressed how all of the support Pathways provided her during her pregnancy was "truly priceless and much needed in this day and age." She went on to say, "Words don't seem to express how much love I felt coming here."

What Is Title X And How Does It Affect Pathways?

A message from our Director

For low-income men and women, publicly funded clinics are an important source of family planning services. These critical services help women avoid unintended, mistimed or unwanted pregnancies as well as give them access to critical preventive care and STI screening and treatment.

The statute governing Title X requires program funds to serve low-income populations at low or no cost, provide clients with a broad range of effective family planning methods and services, and ensures that the services are voluntary. It also stipulates that funds may only go to entities where "abortion is not a method of family planning." Regulations that have been in effect interpret this provision to mean that Title X projects are prohibited from using Title X funds to pay for abortions and must keep any abortion-related activities financially separate from their Title X activities.

Earlier this year, new regulations for Title X grants were published in the Federal Register. The regulations make many changes to the requirements for Title X projects that will significantly reshape the program and provider network available to low-income people through Title X. Specifically, the regulations prohibit federal Title X funds from going to any family planning site that also provides abortion services.

The new final regulation requires that Title X funded activities have full physical and financial separation from abortion-related activities. In addition to separate accounting and health records, providers need to have separate treatment, consultation, examination and waiting rooms, office entrances and exits, workstations, signs, phone numbers, email addresses, educational services, websites, and staff. This new requirement essentially disqualifies any provider from receiving Title X funds if they also offer abortions.

This may seem like a giant win for the pro-life cause, but these new regulations have been legally challenged by 23 states, a number of family planning organizations, state officials, and the American Medical Association on the basis of constitutional and statutory claims. There is a long road of legal battles ahead for the foreseeable future.

What does this mean for pro-life, faith-based pregnancy centers? In essence, it opens the door for these centers to receive federal dollars to provide pregnancy testing, ultrasound exams, STI/STD testing and treatment, and information on abstinence and natural family planning without having to also provide referrals for abortion and abortive methods of contraception. While this appears to be an opportunity to level the playing field to reach and provide valuable services to women in need, there are strings attached that are just as prohibitive for pro-life, faith-based clinics as they are for abortion providers.

Faith-based organizations that want to utilize Title X funds must separate their services physically, just like abortion providers. Faith-based education, counseling, and conversation would have to be provided at an entirely separate location from any Title X funded services. This means that a client seeking help at a Title X funded pregnancy clinic would be able to receive the medical services offered at the clinic, but they would not be able to receive any religious based services at the clinic. Offering prayer or answering a client's questions regarding spiritual matters would be prohibited.

So, where does Pathways land in this debate? While we are thrilled to see that abortion providers will no longer receive federal money for abortion services, that abortion is no longer being defined as a family planning method, and that doors are opening for clinics like ours to have access to more options for funding, we will not be applying for or accepting Title X funds. Pathways has been and will remain funded 100% by our generous donors and private grants.

We remain steadfast as a faith-based organization, offering our services to men and women in need in our community in a loving and welcoming environment. We will continue to provide outstanding evidence-based medical care and advice with compassion and without judgement or pressure. We will open our arms and our hearts to any person seeking care at our clinic, and above all else, they will be shown Christ-like love and

acceptance regardless of their decision.
