

# Covid-19 Safety & Sanitation Procedures

PLEASE GO OVER THESE SAFETY MEASURES WITH YOUR CHILD PRIOR TO THEIR CLASSES SO THAT THEY ARE AWARE OF THE PROCEDURES.

## Government Mandated Shelter-In-Place Order Procedure

- In the Event of A Government Mandated COVID-19 Shelter-In-Place Order, All In Person Classes Will Transition to Virtual Classes. NO Refunds will be Given.

## Health Screening Process

Each staff member and parent will be asked following questions. All answers must be satisfactory prior to continuing on to their classes. If **ANY** dancer or staff member exhibit these symptoms, they will be asked to leave IMMEDIATELY.

- In the past 14 days, have you been around anyone with or have had Covid-19?
- Have you been diagnosed with Covid-19?
- Since your last visit here, have you had any of these symptoms:
  - Cough & Runny Nose
  - Shortness of Breath or Difficulty Breathing
  - Fever
  - Chills, Repeated Shaking with Chills
  - Muscle Pain
  - Headache
  - Sore Throat
  - New Loss of Taste or Smell
  - Nausea and Vomiting
- Classes Will Be Offered Online as Well So They Can Tune in From Home ONLY if test positive for Covid-19 or Exposed (Not because it's raining or too tired to take class).
  - If You Would Like to View from Home, Request a Zoom Link Via Email 24 Hours Prior to Class.

- If your dancer test positive for Covid-19, in order to return, they must return with a negative Covid-19 report.

### Mask

- All Students **MUST** Wear Mask **UPON ENTERING** the studio, **WHILE WAITING** for Class to Begin, and **UPON EXITING** the Studio.
- All Students Ages 3-9 are **Required** to Wear A Face Mask **During** Class.
- All Students Ages 10 and Up are **REQUIRED** to Wear a Face Mask **DURING**

Class.

### Drop Off

- All Students **MUST** be Dropped Off. Students Will Enter Through the Lobby Door.
- If 6 and Under, Parents Must Escort their Child to the Door of the Studio
- All Parents Who Escort Students **MUST** be Wearing a Mask.
- Staff Will Be Standing at the Door of Each Studio to Receive Students.
- Students **MUST** Arrive in Dance Attire
  - No Dressing Rooms will be Available.
- Upon Arrival, Staff Will Take Each Student & Staff Temperature with a No-Touch Thermometer and Note It in a Log
- If Temperature is Over 100.4 Degrees Fahrenheit, the Student will be Sent Home and asked not to return until his/her temperature stays below 100.4 without the use of fever-reducing medication.
- Parents Must Monitor Symptoms

- Staff will Assist Each Child with **HAND SANITIZATION** Upon Arrival.

### **DANCE BAG PROTOCOL**

- Please minimize the amount extra items brought within the studio. Only dance shoes, bottled water/Water Bottle/Gatorade is permitted

### **DANCE STUDIO MEASURES**

- Class Size is Limited
- All Markings will be 6 feet apart and staggered
- For Barre Work everyone will be spread out
- The dance rooms including Ballet Barres, Radios, Floors, Door Knobs, and

Light Switches will be **SANITIZED** (Wiped Down and Sprayed with **CLOROX/LYSOL, & ADDITIONAL CDC APPROVED DISINFECTANTS**) frequently.

### **Teachers/Instructors**

- All Teachers Will Wear **Masks**
- Teachers will **NOT** Touch Students during Instruction
  - All Technical Corrections will be Given Verbally **Restrooms**
- Students & Teachers will have **Separate** Restrooms
- Outside Exposures **ARE NOT PERMITTED** to use restrooms to ensure the Safety against Additional Surface Contamination.
- Restrooms will be Sanitized (Wiped Down and Sprayed with

**CLOROX/LYSOL, & ADDITIONAL CDC APPROVED and DISINFECTANTS)** in between each class.

### **Pick-up**

- All Students **Must** be Picked Up from the Door that they Entered.
  - Please be **ON TIME** to Pick Them Up
  - Parents **MUST** Wear a Mask if Picking Up at Door when Amongst other Dancers to Minimize Airborne Exposure.
- Teachers will Assist Each Child with **HAND SANITIZATION** Upon Exit.



### **If dancer test positive for Covid-19**

- You must quarantine for a minimum of 14 days from the date of positive results
- You must reach out immediately once diagnosis is confirmed!
- We will immediately begin the contact tracing process to investigate if other dancers were exposed and will communicate as necessary with the exposed dancer's parents and provide instructions on how to proceed.
- To return to the studio, student/staff must submit a negative result before allowed to interact with the other dancers.

**If dancer/staff has been in direct contact/exposed to a family member, friend, at school, etc... who has tested positive**

- Please reach out to advise and receive proper feedback
- Dancer must quarantine for 14 days from the studio
- If the dancer receives a negative covid-19 result after 7 days they are allowed back to interact with the rest of their peers. If they test positive, they must follow the protocols above if a positive test is confirmed. If you choose not to test them after 7 days, please follow the CDC recommendation of staying home for 14 days. Symptoms can flare between 2-14 days after exposure!
