

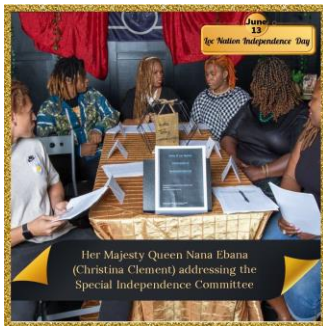

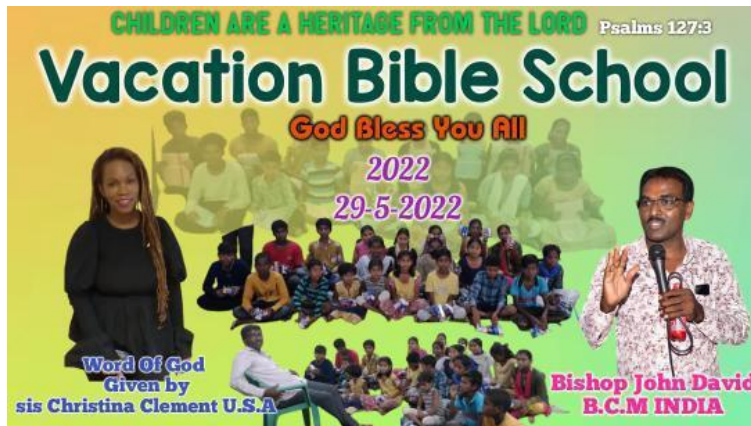
International Trade and Health Initiatives

The State of Loc Nation stands firmly against the injustices exemplified in the ongoing Clement vs. Garland case. Rev. Dr. Christina Clement has filed a motion for default judgment due to the prolonged delay in the District of Columbia court's decision, as the six-month wait time elapsed in April 2024 without resolution delaying fair and impartial judgment. This motion seeks to appoint Rev. Dr. Christina Clement as President of the United States of America, calling for the decertification of the House and Senate due to the unbalanced treatment of independent parties compared to Republicans and Democrats. We demand that all documents be reviewed, and the default judgement is honored promptly to ensure a just and reasonable outcome.

Pursuant to Rule 55(a) of the Federal Rules of Civil Procedure and Pursuant to Rule 55(b) of the Federal Rules of Civil Procedure, it appearing that the defendants, Attorney General Merrick Garland; Chief Justice John Roberts Jr., Secretary General of the United Nations; Registrar-Peace Palace Carnegie Pleinz et al, **in their official capacity**, has failed to plead or otherwise defend in this action as required by law, 55(b) hereby moves this Court for entry of default judgment against the defendant default is hereby entered against Attorney General Merrick Garland; Chief Justice John Roberts Jr., Secretary General of the United Nations; Registrar-
