Subject: Submission of Notice & Request — Self-Determination under U.N. Charter Article 73; Blocked ICJ Filing; Withholding of Revealed the Kingdom of Locs Vol. 2 Book

Dear Office of the High Commissioner,

On behalf of the State of Loc Nation Global Public Benefit Corporation (SoLNGPBC), I hereby submit formal notice and request your consideration of the following matters:

1. Completed Self-Determination Process & Charter-Based Claim

We affirm that SoLNGPBC has fulfilled all internationally recognized steps to assert the right of self-determination, grounded in U.N. Charter Article 73, General Assembly Resolution 1514 (XV), and other decolonization and human rights

instruments.

This claim and its supporting documentation have been publicly disclosed, but administering powers historically responsible for the Trans-Atlantic Slave Trade (UK, France, Spain, Portugal, Netherlands, the U.S.) have failed to act on their binding obligations.

2.

Revealed the Kingdom of Locs: Nazirite Vow Continues Vol. 2

— Restricted Access, Blocked ICJ Submission

In support of our claims, we published a book “Revealed the Kingdom of Locs: Nazirite Vow Continues Volume 2” (Christina Clement) , which documents lineage, census, spiritual-cultural foundations, and legal-theological premises of LOC Nation.

However, on multiple occasions, attempts were made to file this volume (and accompanying documentation) with the International Court of Justice (ICJ), but the material was blocked in transit. The postal money paid was not refunded, and the books were never returned to us. This constitutes obstruction of international legal process and silencing of vital evidentiary record.

We attach:

- * (a) Proof of mailing and tracking attempts;
- * (b) Postal receipts and evidence of non-refund;
- * (c) Public listing details of the book in marketplaces (Better World Books, Amazon) ;
- * (d) Excerpts from Vol. 2 discussing census, pedigree, spiritual claim.

3. Request for OHCHR / Working Group Engagement

We respectfully request that OHCHR, the Working Group of Experts on People of African Descent, or relevant Special Rapporteurs:

1. Record this submission in your communications registry and acknowledge receipt;
2. Review the attached evidence and consider including the obstruction event as part of a human rights / decolonization complaint;
3. Issue correspondence to the relevant States (UK, U.S., France, etc.) urging them to respond, acknowledge LOC Nation's self-determination, and facilitate restitution;
4. If deemed appropriate, request that the blocked volume Revealed Vol. 2 be accepted into the ICJ record or U.N. archives as part of the evidentiary record;
5. Monitor the ongoing situation and recommend investigative or remedial actions under your mandate.

5. Retaliatory Economic Hardship and Withheld Revenues

In addition, the Internal Revenue Service (IRS) has withheld my 2023 and 2024 tax refunds well beyond 180 days without written explanation.

This prolonged non-payment has caused severe financial distress: I have lost my residence and many essential financial resources and am now struggling to remain afloat.

The pattern of delay and non-response appears retaliatory, coinciding with the public disclosure of LOC Nation's self-determination filings and the establishment of the Loc Nation Dollar (LND) as our functional currency.

Further, the refusal of local and federal bodies to acknowledge or process lawful donations made in LND—such as the public contribution tendered to City Hall on September 15 2025—demonstrates how systemic obstruction of our currency and economic instruments directly undermines our ability to fund community restoration and restitution programs.

Without recognition and circulation of LND, we cannot meaningfully repair our people or rebuild red-lined and underfunded communities.

We therefore request that the OHCHR note these financial pressures as part of the broader pattern of interference with the peaceful exercise of the right to self-determination and economic autonomy.

I remain available to supply any additional clarifications, verifications, or documentation.

We deeply appreciate your office's role in protecting human dignity, addressing legacies of injustice, and advancing restorative rights for peoples of African; aboriginal; indigenous, Caribbean, et al descent.

May this submission mark a constructive step in securing recognition, justice, and accountability.
