- **Faith-Rooted Administration:** Establishing a **Divine Government of Accountability**, harmonizing the moral order of God’s law with modern governance.
- **Global Restitution Framework:** Collaborating with Indigenous nations and international bodies to codify transparent, treaty-based economic cooperation rooted in restitution and mutual respect.
