

Wrongful Arrest and False Accusation Accountability Act (WAAFAA)

State of Loc Nation Global Public Benefit Corporation and Trust / Queendom of Loc Nation

**SECTION 1: Purpose** 

To protect the liberty and dignity of individuals by prohibiting wrongful arrests and punishing false accusations that lead to unlawful deprivation of freedom. This Act upholds the right to due process, bodily freedom, and protection from malicious prosecution.

**SECTION 2: Definitions** 

- 1. Wrongful Arrest: The detention or arrest of an individual without probable cause or with knowledge of falsified or fabricated evidence.
- 2. False Accuser: Any person who knowingly provides false testimony, statements, or evidence that results in a wrongful arrest.
- 3. Government Actor: Any peace officer, prosecutor, judge, or other public official acting under color of law.
- 4. Contributory Perjury: Knowingly aiding or conspiring to submit false information leading to a wrongful arrest.

SECTION 3: Prohibition of Wrongful Arrest

- 1. No individual shall be detained or arrested without clear and articulable probable cause based on verified evidence.
- 2. Arrests based solely on fabricated statements or false reports shall be deemed unlawful.



## SECTION 4: Penalties for Wrongful Arrest

1. Government actors who knowingly participate in a wrongful arrest:

Shall be subject to civil liability including damages no less than \$500,000 LND per day of wrongful confinement.

Shall be subject to criminal charges with penalties up to 10 years imprisonment and permanent disqualification from holding public office in Loc Nation jurisdiction.

2. Law enforcement officers involved in wrongful arrests must undergo mandatory suspension and review by a public accountability tribunal.

SECTION 5: Penalties for False Accusations Leading to Arrest

1. Any person or entity who knowingly makes false statements that result in a wrongful arrest:

Shall be fined up to 1,000,000 LND and/or imprisoned for up to 5 years.

Shall be civilly liable for all direct and consequential damages to the accused.

2. Complicity or conspiracy to fabricate evidence or influence a wrongful arrest shall carry the same penalties.

SECTION 6: Right to Civil Remedy



1. Victims of wrongful arrest may file suit in the Loc Nation Tribunal or designated court of equity, seeking:

Financial compensation,

A public declaration of innocence,

Expungement of arrest records,

Injunctions against further harassment.

SECTION 7: Mandatory Recording & Independent Review

1. All arrest events must be recorded (audio & video) and reviewed by an independent oversight body within 48 hours.

2. Any arrest lacking such documentation shall be presumed unlawful unless proven otherwise.

SECTION 8: Public Accountability & Enforcement

1. This law shall be enforced by the Office of Public Integrity of Loc Nation and its allied tribunals.

2. Citizens may initiate Private Right of Action under this law if no timely investigation is commenced.

**SECTION 9: Jurisdiction and Application** 

This Act applies to:



All government agents under Loc Nation jurisdiction and abroad,

Any action affecting citizens or residents of Loc Nation,

Any party operating under agreement, contract, or license with the State of Loc Nation GPBC

Here is a draft affidavit to accompany the Wrongful Arrest and False Accusation Accountability Act (WAAFAA). This affidavit can be used by individuals who were wrongfully arrested to formally assert their rights, document the harm, and initiate proceedings under Loc Nation law.

## Affidavit Declaration

I, the undersigned Affiant, under penalty of perjury under the laws of the State of Loc Nation Global Public Benefit Corporation and Trust, do solemnly affirm the following:

- 2. That such arrest was made without a valid warrant, without probable cause, or was based upon fabricated, false, or misleading information.
- 3. That I was not shown adequate justification at the time of arrest and was denied the opportunity for fair adjudication.
- 4. That the arrest was initiated or supported by one or more individuals who knowingly gave false statements, misrepresented facts, or otherwise engaged in malicious conduct to deprive me of my liberty.
- 5. That I suffered harm as a direct result of the wrongful arrest, including but not limited to:

Emotional distress and psychological trauma

Loss of income or employment

Reputational damage

Physical harm or deprivation of basic needs

Legal expenses or detainment costs

Demand for Relief under WAAFAA

Pursuant to the Wrongful Arrest and False Accusation Accountability Act (WAAFAA):



I demand immediate review of my case by the Office of Public Integrity and/or the Loc Nation Tribunal.

I seek full civil damages in accordance with Section 4 of the Act, in the amount of no less than 500,000 LND per day of unlawful detention.

I request a criminal inquiry into the actions of individuals responsible for false accusations, under Section 5 of the Act.

I demand a public declaration of innocence, formal expungement of arrest records, and all available equitable relief.

I affirm that the rights guaranteed under the Constitution and Civil Code of the Loc Nation were violated, and hereby invoke full legal protections as a sovereign beneficiary.
