Addressing Governance of Majority Parties; their protection from the tyranny of the minority acts. Historical evidence of over 500 years of victim grievances.

Furthermore, S.O.L.N is committed to maintaining integrity and efficiency by implementing measures to address false claims and evidence of "addiction to complaining" and/ or evaluation of "victim mentality"; Chronic Post traumatic Syndrome Disorder (PTSD); Post traumatic Syndrome Disorder (PTSD); Spiritual warfare (lust, gluttony, pride, envy, wrath, sloth and greed) ensuring that grievances and promoting constructive dialogue for effective resolution and/ or proper mental illness treatment.

SE prioritizes economic diversification and resilience-building efforts to reduce dependency on specific sectors and enhance its economic stability and growth prospects. Additionally, SE will enforce and collect liens, all allodium titles, and all other amounts owed, including interest, as restitution for the wrongs committed by major powers to the majority party. (See lien, Bill of Cost and Bill of Cost Clarification)

3.2 Foreign Direct Investment

SE welcomes foreign direct investment through competitive incentives, regulatory reforms, and infrastructure development projects aimed at attracting investors and fostering sustainable economic development. Investors have no governing power but are encouraged to contribute to achieving a better global impact.

Article 4: Legal and Governance Framework

- 4.1. SE adopts a robust legal framework that conforms to international standards, ensures transparency, accountability, and the protection of human rights and fundamental freedoms for all residents within its jurisdiction.
- 4.2. SE establishes diplomatic missions and consulates abroad to promote bilateral relations, advocate for recognition, and engage in international legal processes, including arbitration and dispute resolution mechanisms.

Article 5: Social Cohesion and Inclusive Governance

5.1. SE promotes inclusive governance structures that respect cultural diversity, protect both majority and minority rights, and uphold principles of equality and social justice among its diverse population.

Article 5: Social Investments

5.2 Education, Healthcare, and Social Welfare

SE invests in education, healthcare, and social welfare programs to enhance the well-being and quality of life for all residents, fostering unity and cohesion within its society. Additionally, SE will match cost payments with corporations found to violate human health, social welfare, and education, and have been sanctioned to pay into its remedy fund, whichever is greater, with approved budgets set forth by C.L.C.L.L.C.

Article 6: Diplomatic Strategy and Advocacy

- 6.1. SE implements a proactive diplomatic strategy aimed at building coalitions of support among like-minded states, international organizations, and civil society entities that uphold principles of sovereignty and self-determination.
- 6.2. SE conducts public diplomacy campaigns, media outreach, and cultural exchanges to raise awareness about its aspirations, achievements, and contributions to the global community.

Article 7: Implementation and Review

- 7.1. SE establishes mechanisms for the effective implementation, monitoring, and periodic review of this framework document to assess progress, address emerging challenges, and adapt strategies as necessary.
- 7.2. SE commits to transparency, consultation with stakeholders, and accountability in the implementation of policies and initiatives outlined in this framework document, ensuring responsiveness to the needs and aspirations of its inhabitants (Nephesh hummus: souls on earth).

Article 8: Protection of Rights and Just Governance

- 8.1. SE affirms its commitment to safeguarding the rights and liberties of all individuals within its jurisdiction, conforming to and conforming with international standards and principles of fairness and justice.
- 8.2. SE guarantees that no changes shall be made to its legal and governance framework that are not deemed right, fair, and just to all people. Decisions shall be made transparently, with accountability to the populace.

Any agreement that reveals as violation will be null and void, followed by restitution demand and enforcement.

Article 9: Global Supremacy and Divine Promise

9.1. The State of Loc Nation Global, Public Benefit Corporation (hereinafter referred to as "Loc Nation Global") asserts its sovereignty and independence over all lands and territories defined by divine promise, recognized conforming to and conforming with principles of international law and the right to self-determination.

9.2. Global Supremacy Clause

Loc Nation Global hereby declares a global supremacy clause, affirming its authority over all land and resources within its defined territory, as established by divine promise and historical entitlement fee simple absolute allodium.

- 9.3. This global supremacy extends to all laws, treaties, and agreements enacted by Loc Nation Global, which shall prevail as the supreme law of the land, ensuring justice, equality, and rights for all inhabitants under its jurisdiction globally.

- 11.4. Financial Incentives: Incentives, such as tax benefits and subsidies, shall be provided to encourage the use of the S.O.L.N currency in domestic and international transactions, ensuring competitive advantages for businesses and economic growth.

Directive to Print S.O.L.N Currency

To: Printing Authority

Subject: Printing and Distribution of State of Loc Nation Global, Public Benefit Corporation (S.O.L.N) Currency

Directive:

- 1. Initiation of Printing: The Printing Authority is hereby directed to initiate the printing of the S.O.L.N currency notes and coins.
- 2. Leadership Nomination: Each state and country under the jurisdiction of the State of Loc Nation Global (S.O.L.N) shall nominate a designated leader responsible for overseeing the distribution and circulation of the S.O.L.N currency within their respective territories each reporting as pursuant to Article 10.
- 3. Collaboration: The selected leader from each state and country shall collaborate with the Printing Authority to ensure timely distribution and availability of the S.O.L.N currency to banks, financial institutions, and businesses.

12.5 Harmonization and Compliance

12.6 Building Trust and Credibility

Foster trust and credibility through transparent governance, reliable financial reporting, and effective oversight mechanisms, demonstrating the S.O.L.N currency's security and reliability to stakeholders.

Supreme Authority Declarations

Supreme Authority Declaration to Dynasty Healing Corp

Supreme Authority Declaration to Artist Admin Team

- Article 13 Protection Against Threats from Other Sovereign Entities; States Conforming to International Law and Conforming with State of Loc Nation Global, Public Benefit Corporations laws set forth.
- 13.1. Diplomatic Channels: Sovereign entities shall maintain diplomatic relations and engage in dialogue through diplomatic channels to resolve disputes peacefully. This includes regular communication, negotiation, and participation in international organizations and forums aimed at promoting cooperation and resolving conflicts.
