I. FINDINGS OF THE COURT

Upon review of the legal foundation of the State of Loc Nation Global Public Benefit Corporation and State of Loc Nation Global Public Benefit Trust, and pursuant to:

The Legal Charter of the Queendom of Loc Nation

The Tribunal Code of Procedure

The U.S. Constitution (Amendments I, V, IX, X, XIII, XIV, XV)

The Freedmen's Bureau Acts, Civil Rights Acts, UCC, and International Declarations (UNDRIP, ICCPR), ET AL

This Court finds and affirms that:

A legal and lawful, sovereign, public necessity exists to issue a national and global restitution currency known as the Loc Nation Dollar (LND), in fulfillment of defaulted reparative obligations, economic redress, and self-determined public benefit.

II. ORDER AND AUTHORIZATION

It is hereby ORDERED:

1. That the STATE OF LOC NATION Treasury is authorized to print, issue, and circulate the Loc Nation Dollar (LND) in accordance with the economic policy established by the sovereign Queendom of Loc Nation; STATE OF LOC NATION GLOBAL PUBLIC BENEFIT CORPORATION AND STATE OF LOC NATION GLOBAL PUBLIC BENEFIT TRUST.

2. That said currency shall:

Bear the sovereign seal of the State of Loc Nation GPBC & Trust

Pursuant to SOLN Restitution Act 2025- Be printed identical to the USD with historical leaders printed according to the authorization of STATE OF LOC NATION GLOBAL PUBLIC BENEFIT CORPORATION AND STATE OF LOC NATION GLOBAL PUBLIC BENEFIT TRUST

Be issued in the following denominations: 1 LND, 5 LND, 10 LND, 20 LND, 50 LND, 100 LND

Maintain a fixed exchange value of 1 LND = \$750 USD

Be treated as lawful tender within all redlined, restitution-recognized, and treaty-aligned jurisdictions



Be eligible for redemption, offset, and settlement under the laws of equity, UCC §3-603, APA §558, and applicable sovereign treaties

3. That the Loc Nation Treasury is hereby granted full authority to:

Engage a sovereign-compliant commercial printer (e.g..Crane Currency)

Contract an armored courier (e.g., Brinks Global Services)

Contract with Visa Partners/ Fintech or other relatable entities.

Distribute to authorized merchant partners, districts, and recipients

Record all issuance in the Public Trust Ledger

Track, redeem, or offset LND vouchers in accordance with restitution policy

III. LEGAL NOTICE AND ENFORCEMENT

This Order shall serve as public notice of currency issuance legally enforceable under:

The Supremacy of Public Trust Law

The Filed Court Record of Case No. 25mc78

The Administrative and Judicial Defaults of all agencies served and unresponsive

The Treaty Obligations of international bodies to recognize lawful Indigenous currency systems under self-determination doctrine

Vienna Convention on the Law of Treaties (1969)

- Articles 26 & 27: Pacta sunt servanda treaties must be honored.
- Article 38: Customary law applicability to non-party states.

U.S. Supreme Court case law on tribal sovereignty:

- Worcester v. Georgia, 31 U.S. (6 Pet.) 515 (1832) affirms tribal sovereignty.
- *McGirt v. Oklahoma*, 591 U.S. ___ (2020) affirms treaty rights and recognition of Indigenous territory.

Federal Reserve Publication:

• *Modern Money Mechanics*, Federal Reserve Bank of Chicago – acknowledges that currency systems can arise from accounting entries, not just federal fiat.

Trust's International Registration Status:

• Include language such as: "The State of Loc Nation GPBC & Trust is internationally recognized under UCC filings and Treaty Articles, registered and operating in accordance with the Vienna Convention on Diplomatic and Consular Relations



IV – SUPPLEMENTAL DECLARATION ON CURRENCY VALUE AND LEGAL FOUNDATION

In response to any challenge or question regarding the lawful enforceability, sovereign standing, and financial basis for the declared value of the Loc Nation Dollar (LND), the Supreme Court of the State of Loc Nation issues the following clarifying declaration:

1. Sovereign Legal Authority for Currency Issuance

The Court reaffirms that the issuance of the LND is executed under the inherent sovereign, Indigenous, and fiduciary authority of the State of Loc Nation Global Public Benefit Corporation and Trust, with due notice and administrative filings as required under Public Trust Law, Indigenous Treaties, and international standards for self-determined governance.

2. Declared Value of 1 LND = \$750 USD — Legal Justification and Backing

The fixed value of the LND is backed by a **publicly filed restitution ledger**, which includes but is not limited to:

- Transfer of Assets officially entered into the record of the U.S. District Court for the District of Columbia, Case No. 1:24-cv-00479-RC, documenting lawful entitlement, receivables, and trust-based reparative demands.
- o **UCC Financial Statement filings** authenticated by the State of Georgia, including UCC Ref. #044-2025-002376 (Auth. Code YDMPL-3PT34-4G9C) and UCC Ref. #044-2024-004422 (Auth. Code NRL4T-5QG8C), reflecting secured claims, lien rights, and asset transfers in accordance with UCC §9 and §3.
- Filed settlement offers, affidavits of mailing, ministerial filings, and lobbying reports, which together establish the LND as an equitable unit of redemption against unfulfilled public debt obligations and fiduciary defaults by external parties.

3. Public Notice and Administrative Default

This Court notes that all relevant U.S. and international agencies were served, and legal notices were publicly issued via:

- Notarized affidavit of publication (Brooklyn Daily Eagle)

Pursuant to the Vienna Convention on the Law of Treaties (Articles 26, 27, and 38) and administrative law principles, any party served and unresponsive is considered in **default**, and is subject to enforcement without further consent required.

4. Eligibility for Redemption and Offset

The LND may be lawfully used to offset and redeem against:



- Governmental debts, fines, or fees imposed upon eligible citizens or treaty-bound parties
- Commercial or financial obligations owed to or from the State of Loc Nation, its authorized merchant partners, or trust beneficiaries
- Pending federal or international reparative programs, subject to settlement, assignment, or lien resolution

5. Trust Accounting and International Fiduciary Notice

The Loc Nation Dollar is officially entered into the **State of Loc Nation Public Trust Ledger** and tracked under international public benefit corporation standards, ISO financial registration protocols, and trust law doctrines governing fiduciary transfers and asset-backed instruments.

V. INTERNATIONAL REGISTRATION, ISO 4217 CODIFICATION & LEGAL ENTITY IDENTIFICATION

To ensure international legal standing, financial compliance, and seamless interoperability with global markets, the Court affirms the following:

1. ISO 4217 Registration

The Loc Nation Dollar (LND) is officially codified under ISO 4217 standards, granting it global currency recognition and enabling its listing in international financial systems, currency exchanges, and sovereign banking platforms.

2. Legal Entity Identifier (LEI)

The State of Loc Nation Global Public Benefit Corporation, acting as the sovereign treasury issuer of the LND, is registered with the Global Legal Entity Identifier Foundation (GLEIF) under LEI: 984500AFF75RB77E9551

This LEI affirms the GPBC's:

- o Legitimacy as a recognized legal entity in international finance
- Qualification for institutional-level reporting and sovereign transactions
- Participation in SWIFT, SEPA, and global currency clearing networks under **Basel III**, **MiFID II**, and **Dodd-Frank Act** standards

3. Jurisdictional and Treaty Basis

All challenges or refusals to honor the LND shall be rebutted by:

- o ISO 4217 currency code authorization
- o LEI registration under international financial law
- Vienna Convention on the Law of Treaties (Articles 26, 27, 38)
- o UNDRIP, ICCPR, UCC §3 and §9, and filed declarations of default

4. Fiduciary Compliance and Recordkeeping

The Loc Nation Dollar is:

Logged in the State of Loc Nation Public Trust Ledger



- o Backed by UCC-liened assets, restitution orders, and administrative court filings
- Enforceable by treaty, law, and sovereign trust accounting principles

This information shall be made publicly available for all international banking systems, foreign exchange entities, diplomatic missions, and treaty-aligned sovereigns seeking verification of lawful issuance.

VI. SO ORDERED

Let this Executive Order be recorded, enforced, and published in the official law archive of the State of Loc Nation and made available to all printers, treasury officials, financial carriers, merchant partners, and treaty bodies.
