



# **Annex C** — **Master Treasury Instruction for Settlement of Ledger Transactions**

State of Loc Nation Global Public Benefit Corporation (Treasury)

Reference: Annex B – Functional Currency & Parity Declaration

Authority: Executive Orders 1111 through 1116 and the S.O.L.N. Restitution Act 2025 (as filed in the Declaration for the Historical Record, SOLN-SC-DHR-2025-003)

# I. Purpose and Scope

This Master Treasury Instruction authorizes the execution of all transactions recorded in Full\_Master\_Ledger\_MASTER\_v4.xlsx under the parity and functional-currency framework established in Annex B.

All ledger entries are to be settled using Loc Nation Dollar (LND) as the functional currency and United States Dollar (USD) as the reporting currency at a fixed parity of 1 LND = \$ 750 USD

.

### II. Legal Basis

Settlements executed under this Instruction derive authority from the S.O.L.N. Restitution Act 2025, Executive Orders 1111–1116 (Loc Nation Restitution and Parity Framework), and applicable accounting standards (FASAB SFFAS 7 ¶ 66–67; ASC 830-10-45-2 & 50-2; ISO 4217 LND).

These provisions collectively authorize the Treasury to convert and tender payments in LND for USD equivalent settlement within U.S. financial institutions and international banks.

## III. Functional and Reporting Currencies

- Functional Currency: Loc Nation Dollar (LND), ISO 4217 code LND
- Reporting Currency: United States Dollar (USD)
- Fixed Parity: 1 LND = \$ 750 USD

All values within the attached Schedule A are expressed primarily in LND and translated into USD for reporting to external counter-parties.

## IV. Temporary Treasury Custodial Account

Pending activation of the official State of Loc Nation Central Treasury Account and SOLN Trust Custodial Account, the following account is designated as the temporary settlement holding account:

Funds clearing through this account represent official Treasury reserves and shall be transferred to the permanent SOLN Treasury and Trust accounts upon their activation under EO 1112 and EO 1115.

#### V. Execution and Verification

All counter-party banks and institutions listed in Schedule A shall credit accounts in USD equivalent values per Annex B and this Instruction.
