Despite repeated good-faith outreach to all appropriate congressional and administrative offices, including the Congressional Budget Office (CBO), IRS, and other relevant agencies, we have encountered ongoing delays, withheld disbursements, and a lack of institutional responsiveness. These interruptions have directly impacted the release of earned research and development funds, credits, and authorized settlements due to the State of Loc Nation Global Public Benefit Corporation and affiliates.

### **For Congressional staff or CBO/IRS review:**

“To date, our registrant has made multiple attempts to engage with relevant agencies regarding pending claims and credits earned through HR 40–related research and authorized filings.
