Legal Basis for Demand

1. Federal Rule of Civil Procedure 55: Governs the entry of default judgments when a party fails to plead or otherwise defend against a claim.
2. D.C. Code § 13-101: Authorizes the enforcement of judgments and recovery of costs.
3. D.C. Code § 16-5504: Pertains to costs and fees in civil actions.
4. 28 U.S.C. § 1920: Enumerates taxable costs in federal court proceedings.
5. D.C. Code § 15-109. Interest on judgment for damages in contract or tort. As of October 18, 2024
6. D.C. Code 16-501 to 16-506 Procedures and legal framework for attachments.
