## DECLARATION OF THE LOC NATION DOLLAR (LND) - CURRENCY DESIGN DOSSIER

By the unrebutted authority of the State of Loc Nation Global Public Benefit Corporation and Trust, under the Restitution Act of 2025, and pursuant to filings entered into record under the U.S. Constitution, Freedmen's Bureau Acts, Civil Rights Acts, UNDRIP, ICCPR, and the SOLN De Jure State Declaration, this Court and Treasury Tribunal hereby issues its directive for the lawful tender and design of the Loc Nation Dollar (LND). The LND stands as lawful tender at 1 LND = 750 USD, and its design portfolio shall memorialize the leadership, sacrifice, and sovereignty of the African diaspora and its descendants, culminating in the living sovereignty of the present Empress Queen.

#### Legal Effect

- 1. This dossier shall be entered into the permanent record of the State of Loc Nation Supreme Court and Treasury Tribunal.
- 2. The denominations, portraits, and symbols are lawfully enacted and irrevocable, binding upon all currency engravers, custodians, and counterparties.
- 3. Any refusal to recognize or reproduce this portfolio without due process shall constitute civil obstruction under U.S. Constitutional law, International Treaty law, and the SOLN Restitution Act 2025.

#### **Historical Hook and Completion Clause**

This Directive for the Loc Nation Dollar (LND) is expressly linked to:

- The 2015 Women on 20s petition delivered to the U.S. Treasury;
- The April 20, 2016 Treasury Directive by Secretary Jacob Lew ordering the redesign of the \$20 note to feature Harriet Tubman;
- The failure of subsequent administrations to complete that mandate;
- The Official Executive Memorandum and Enforcement Directive (SOLN-0625-EXECMEM-001) assuming executive authority and directing Treasury to recognize LND tenders;
- The Motion for Injunctive Relief (Case 1:24-cv-00479-RC; USCA 24-5263) demanding leadership and budget control for civil rights enforcement.

By this record, the State of Loc Nation GPBC lawfully assumes custodial authority to complete the Tubman redesign project and expand it to include additional diaspora leaders. The costs of printing and minting are hereby authorized and billable to the SOLN Treasury and Loc Community Association Credit Union (LCACU).

**Commercial Enforcement Clause** This Directive is further secured under the following Uniform Commercial Code filings, entered into public record and certified by the Clerk of Superior Court of DeKalb County, Georgia: - UCC Financing Statement No. See QR Code / Authentication Code], covering accounts receivable, restitution claims, HR-40 research, and all





### derivative assets.

All obligations for engraving, printing, and minting of the Loc Nation Dollar (LND) are enforceable as secured claims under UCC Article 9. Any refusal to comply constitutes commercial obstruction, subject to default judgment and restitution enforcement.
