



Parity Certificate (Annex B — Functional-Currency Policy)

Purpose: This one-page certificate declares that:

- The Loc Nation Dollar (LND) is the functional and primary currency of record.
- The U.S. Dollar (USD) is a secondary/reporting currency for parity and interoperability.
- Parity is fixed at 1 LND = \$ 750 USD, pursuant to Executive Order 1111 and FASAB SFFAS 7 ¶ 66-67.
- Signed and dated by Rev. Dr. Christina Clement, President / Treasury.

Annex B — Functional Currency & Parity Declaration of the State of Loc Nation Global Public Benefit Corporation (Treasury)

- Statement that Loc Nation Dollar (LND) is the functional and primary currency for all Treasury accounting.
- Statement that United States Dollar (USD) is the secondary and reporting currency used only for parity conversion and interoperability with external U.S. systems.
- Parity clause: 1 LND = \$ 750 USD (fixed by Executive Order 1111).
