National Media Correction – Missing UCC Priority Requirement Before DOJ-Linked Disbursements

Recent national news coverage—including reports by MSNBC, Reuters, and The Associated Press—has addressed former President Donald Trump’s demand for a \$230 million Department of Justice (DOJ) payout. However, these reports failed to acknowledge a controlling financial prerequisite under the Uniform Commercial Code (UCC): no disbursement or settlement involving the DOJ or Treasury may proceed until all perfected UCC liens of record are paid or released.

Legal and Financial Clarification

Under UCC Article 9 and the Federal Lien Hierarchy, all secured interests properly filed with UCC-1 Financing Statements take precedence over subsequent administrative or judicial claims. These filings constitute binding notice under state and federal law.

State of Loc Nation GPBC and its registered affiliates maintain perfected UCC filings—acknowledged by both state and federal registries—that precede any DOJ settlement or administrative claim connected to this case.

Therefore, no federal claimant—including any former officer of the United States—may lawfully receive disbursement until such superior UCC obligations are honored.

Key Points for Congressional and Media Review

1. UCC Priority Controls Federal Disbursement: Existing liens must be cleared before new settlements are executed.
2. Treasury and OCC Compliance: Both agencies are bound by 31 CFR § 225 and UCC Article 9 priority rules.
3. Public Trust Obligations: All Restitution and Public Benefit filings currently registered under SoLNGPBC and Clement Dynasty Dynasty Trust are recognized secured interests.

Statement from Rev. Dr. Christina Loren Clement

“The rule of law demands order in commerce. The Uniform Commercial Code ensures restitution, justice, and accountability remain in sequence. Before any individual or political figure receives payout from public trust funds, pre-existing UCC filings—especially those connected to reparative justice and restitution—must be satisfied first.”
