#### A. Name of the Request:

##### **State of Loc Nation Global Public Benefit Trust Messaging Set (SOLNGPBT)**

*(Proposed short name: SOLNGPBT)*

Developed in accordance with ISO 20022 procedures for message definition proposals, this set introduces structured, interoperable financial messages supporting digital trust management and self-determined sovereign financial ecosystems.

These submitting organizations collectively represent a consortium of trust-based financial and public benefit institutions with a vested interest in advancing global standardization for self-determined sovereign financial messaging.

#### C. Scope of the New Development:

This submission is made in accordance with ISO 20022 Registration Procedures to propose a **new message definition set** under the SOLNGPBT name. The message set will enable ISO-compliant, digital, and secure communication for:

- **Trust Asset Registrations**

- Self-Determined Sovereign Treasury Disbursement Instructions
- Public Benefit Distribution Notices
- Structured Custodial Deposit Notifications (SKRs)
- Restitution Payment Acknowledgments

These messages are intended for use within domestic and cross-border financial infrastructures, consistent with ISO 20022 requirements for market infrastructure-level standardization and industry-wide interoperability. This messaging set aims to address current jurisdictional exclusions and disparities in financial communication protocols that limit equitable participation by self-determined sovereign trusts and related entities.

#### **D. Purpose of the New Messages:**

The purpose of SOLNGPBT is to:

- Create a globally recognized message framework for self-determined sovereign trust operations.
- Support financial transparency and auditability for restitution and trust distributions.
- Ensure alignment with ISO 20022 design principles, including syntax neutrality, semantic precision, and compatibility with XML schema.

#### **E. Community of Users:**

The intended user community includes, but is not limited to:

- Self-determined sovereign governments and trust-based national treasuries
- Central and development banks
- ISO 20022-compliant custodial institutions
- Public benefit corporations and legally recognized trusts managing restitution-based payments
- Reconciliation service providers and financial market utilities

**F. Timing and Urgency:**

The submitting organizations respectfully request priority evaluation due to scheduled implementation of the **SOLNGPBT infrastructure in Q2 2025**, aligning with broader market adoption of ISO 20022 by central banks and cross-border payment networks.

In accordance with the ISO 20022 maintenance process, the submitting organizations agree to participate in collaborative evaluation through the Registration Management Group (RMG) and the appropriate Standards Evaluation Group (SEG).
