Executive Summary & Purpose

Documenting the adoption of ISO, PCI-DSS v4.0, and EMV technical standards to ensure interoperability with global networks (Visa, Mastercard, SWIFT, FedNow) and parity with J.P. Morgan-level governance and security.

Governance Framework

SOLN GPBC \rightarrow SOLN Central Bank \rightarrow Loc Community Association Credit Union, under a unified audit and compliance program directed by the Office of the President.

Security and Cryptography Alignment

Implements ISO 9564 (PIN), 11568 (Key management), 13491 (HSM), and 27001 (ISMS) controls; adheres to PCI-DSS v4.0 and EMVCo 4.4 certification standards.

Ongoing Conformance Procedure

Annual review and update cycle; ISO edition tracking log; external audit by certified assessor; maintenance of change control and incident response documentation.

Request

Please assign a new six- to eight-digit **Issuer Identification Number (IIN/BIN)** to the State of Loc Nation Central Bank / Loc Community Association Credit Union for use in identifying cards, wallets, and digital payment instruments issued under SOLN authority. We respectfully request:

- 1. confirmation of receipt,
- 2. any required forms/fees, and
- 3. next-step guidance for completing the registration.

Clarification

The Loc Nation Dollar (LND) becomes transactable on the same rails as USD and EUR *because it speaks the same ISO languages* (8583 and 20022).

- BIN/IIN registration simply prevents number collisions and allows global switches (VisaNet, Mastercard Banknet, SWIFT) to recognize SOLNissued cards or tokens.
- We remain the issuing authority; ABA or ISO are merely **registry custodians**, not supervisors.
