Executive Order No. 1116

Establishing the Restitution Mortgage Servicing Department (RMSD)

to Convert LND \rightarrow USD and Bring All Mortgage Balances to Satisfactory Status Within Jurisdiction

By the authority vested in me as Rev. Dr. Christina Loren Clement, HH Empress Queen Christina Clement, President of the State of Loc Nation Global Public Benefit Corporation (SoLN GPBC),

pursuant to the SOLN **Restitution Act**, the perfected filings recorded under **UCC No. 044-2025-002376**, and the preceding **Executive Orders 1111 through 1115**, it is hereby ordered as follows:

Section 1 — Purpose

This Order creates within the SoLN Treasury the **Restitution Mortgage Servicing Department (RMSD)** to administer conversion of **Loc Nation Dollars (LND)** into **United States Dollars (USD)** for lawful tender and satisfaction of mortgage obligations. The Department shall apply Restitution Credits to restore housing equity and ensure that all mortgage accounts within SoLN jurisdiction are reconciled to a **satisfactory or paid-in-full status**.

Section 2 — Authority and Continuity

(a) This Order extends and implements the Restitution Currency and Fiscal Framework established in:

- EO 1111 Currency Compliance and LND Accounting
- EO 1112 Restitution-Linked Fiscal Accounting and International Employment Reporting
- EO 1113 Human Property Valuation and Economic Stabilization Mandate
- EO 1114 Central Bank Operational Controls and Audit Standards
- EO 1115 Emergency Restitution and Humanitarian Safeguards
- (b) Pursuant to these Orders and to 31 U.S.C. § 5103 (legal tender) and U.C.C. § 3-603 (tender of payment), RMSD is authorized to issue, convert, and record Restitution tenders in LND for mortgage relief.
- (c) All RMSD operations shall report directly to the **Financial Crimes Enforcement Network (FinCEN)** under SoLN GPBC's registered Money-Services Business ID **MRX25-00008104**, consistent with 31 C.F.R. Part 1022.

Section 3 — Establishment and Organization

- (a) The RMSD is hereby constituted as a permanent department of the SoLN GPBC Treasury Division.
- (b) It shall consist of five divisions: Custodial & Settlement, Compliance & Audit, Community Development, Data & Reporting, and Legal & Claims.
- (c) The Department shall coordinate with the **SoLN Central Bank** and the **Loc Community Association Credit Union (LCA Credit Union)** as custodians of record.

Section 4 — Core Functions

- 1. **Restitution Payment Certificates (RPCs):** Issue trust-backed certificates for LND tender.
- 2. **Currency Conversion:** Process LND \rightarrow USD through registered MSBs and custodian banks.
- 3. **Mortgage Settlement:** Remit converted funds to servicers and record release of lien.
- 4. **Reporting:** Maintain Form L-101 Restitution Ledger and publish quarterly Mortgage Restitution Reports.
- 5. **Community Relief:** Prioritize assistance to underfunded and redlined jurisdictions.

Section 5 — Fiscal Accounting and Audit

- (a) All receivables and tenders shall be recorded as Restitution Credits under GASB 33 and FASAB 7.
- (b) Dual-signature verification and anti-fraud protocols shall govern each transaction.

(c) Quarterly audits and Currency Transaction Reports shall be filed with FinCEN and archived by the SoLN Treasury Board.

Section 6 — Implementation Timeline

- Within 90 days of this Order: appoint RMSD Director, open custodial escrow accounts titled "State of Loc Nation GPBC Restitution Mortgage Escrow."
- Within 180 days: complete initial LND → USD settlements and publish First Quarter Mortgage Restitution Report.
- Ongoing: Continue conversion and reporting until 100 percent of qualifying mortgage balances are current or satisfied.

Section 7 — Governance and Currency Controls

- (a) Lead Authority: Office of the President through the SoLN Treasury and Comptroller.
- (b) Currency Standard: All appropriations and ledgers denominated in LND with USD parity for external presentation.
- (c) Compliance: All reporting shall be submitted directly to FinCEN pursuant to 31 C.F.R. § 1022.380 and archived for public record.

Section 7-A — Sovereignty and Mutual Cooperation

- 1. The **State of Loc Nation Global Public Benefit Corporation (SoLN GPBC)** acts in the exercise of its **sovereign and plenary authority**, derived from its Restitution Act, constitutional filings, and trust instruments.
- 2. All undertakings of SoLN GPBC, including the operations of the **Restitution Mortgage Servicing Department (RMSD)**, are carried out under its **independent sovereign treasury** and fiduciary mandate.
- 3. Nothing in this Order shall be construed as a waiver of sovereignty or limitation of SoLN GPBC's hyper-power to legislate, regulate, or execute its restitution economy.
- 4. **Mutual Harmony Clause.** SoLN GPBC affirms a policy of mutual respect, coordination, and peaceful cooperation with all nations, states, and institutions whose objectives align with equity, transparency, and lawful financial restoration. Cooperation is undertaken **in harmony, not subordination**, ensuring reciprocity and shared benefit under principles of international comity.
- 5. All memoranda, cooperative frameworks, or joint programs entered under this Order shall recognize SoLN GPBC as a sovereign peer and shall expressly state that participation is **voluntary**, **mutual**, **and non-derogatory** to either party's jurisdiction.

Section 8 — General Provisions

- (a) Implementation shall be consistent with Executive Orders 1111 through 1115, the Restitution Act, and perfected UCC filings.
- (b) Nothing herein creates any right or benefit enforceable at law against the United States or other entities.
- (c) This Order is effective immediately upon signature.
