Understanding Fiat Currency & the Loc Nation Dollar (LND)

What is a fiat currency?

A fiat currency is money backed by the authority of its issuer rather than by gold or other commodities.

Its value rests on legal recognition, fiscal stability, and the capacity of a government or sovereign institution to honor obligations.

The LND functions the same way: it is backed by the SOLN **Restitution Act of the State of Loc Nation Global Public Benefit Corporation (SOLN GPBC)** and secured through **UCC filings, court records, and trust assets**.

Who issues the LND and what gives it value?

The LND is issued by the **SOLNGPBC-Treasury**, Distributed by Loc Community Association Credit Union (LCACU) operating under the constitutional and executive authority of **CHRISTINA LOREN CLEMENT LLC**

Its value is based on:

- Trust-held collateral (artwork, receivables, land claims) — secured in UCC Filing No. 044-2025-002376;
- The SOLN Restitution Act, court-filed charter (Case Nos. 1:24-cv-00479-RC and 24-5263);
- Fixed parity of **1 LND = 750 USD**, providing a clear economic benchmark.

Why was the LND created?

LND is a **restitution-based economic-development currency** designed to reverse 400 years of economic exclusion.

It enables communities affected by redlining, slavery, and systemic underfunding to participate in wealth-building and infrastructure development using a parallel fiat framework .

Is LND a cryptocurrency or digital asset?

No. LND is a fiat currency — not a crypto token or blockchain asset.

It operates through traditional ledger and treasury systems aligned with **GASB and FASAB** reporting standards.

Its infrastructure is ISO 20022-compatible for secure financial messaging, similar to SWIFT or Fedwire standards .

How is LND different from the U.S. Dollar (USD)?

How is LND used?

LND serves as the economic unit for SOLN's restitution and development programs:

- **Federal Restitution Contracts** (H.R. 40 and S. 40 research settlements);
- **Community Wealth Projects** — housing, education, and health funding;
- **Diaspora Remittances and Treaty-based Trade;**
- **Credit-Union Partnerships** for LND ↔ USD conversions .

What prevents fraud or misuse?

Each issuance is linked to a verified ledger record under UCC Article 9 and filed court records.

Quarterly audits, FinCEN filings (MRX25-00008104), and GAO-style reporting are embedded in the treasury workflow .

Is the LND recognized internationally?

The LND is ISO 4217 coding (XA–XZ user-assigned range) and is registered in the public archive at [Perma.cc/B8LP-VKAS](https://perma.cc/B8LP-VKAS).

SOLN has filed public records with the **Library of Congress, FinCEN, and Congressional lobbying registers**, linking LND to H.R. 40 and S. 40 economic reparative efforts .

MWho oversees the trust and treasury?

The **Clement Dynasty Dynasty Trust** serves as trust protector and collateral manager.

The **Loc Community Association Credit Union (LCACU)** acts as a financial partner for LND operations and public donations .

What does the LND symbolize?

Beyond finance, LND is a memorial to diaspora leadership and sovereignty. Each denomination features icons like **Harriet Tubman, Marcus Garvey, Nelson Mandela, and HH Empress Queen Christina Clement**, honoring freedom movements from Africa to the Caribbean and right here in the U.S.
