Representatives: (27) elimination of the requirement of a three-fifths vote for the passage or adoption of certain measures or matters, I am submitting the requested materials for review.

The research conducted under Christina Loren Clement LLC and State of Loc Nation Global Public Benefit Corporation pertains to the economic analysis, legislative framework, and policy recommendations for restitution during the illegal kidnapping during the Trans Atlantic Slave Trade and his continuous impact to this current day as outlined in H.R. 40. This research aligns with the Congressional Budget Office's (CBO) determination of a \$20 million allocation, which was assessed based on the scope, impact, and necessary resources dedicated to this initiative. The funding supports the comprehensive evaluation of historical injustices, economic disparities, and legislative remedies central to H.R. 40. We have yet to receive this compensation in full. (See Certified UCC 1 financial Statement Reference # 044-2025-000334 Authentication Code FBGRX-DZTKF-EBBE DATED 01/24/2025.)

Furthermore, the Certified UCC 1 Financing Statement (File No. 044-2024-004422, Authentication Code: NRL4T-5QG8C-PWHH) filed with Dekalb County Superior Court substantiates the financial claims and accounts receivable related to H.R. 40 research. This filing, authenticated by the Clerk of Superior Court, provides legal documentation that supports the funding allocation. The UCC 1 Financing Statement explicitly references HR 40 research as an enforceable financial claim, listing accounts receivable pursuant to 15 USC 7021 (Transferable Records), which establishes the validity of electronically documented financial obligations under



federal law. Additionally, it cites the Equal Access to Justice Act, reinforcing the right to compensation for documented legal and financial claims.

The financing statement also details a lump sum settlement of \$500 quadrillion with 50% interest, underscoring the significance and scale of the financial obligations tied to HR 40 reparations initiatives. This financial documentation serves as an undisputed record of the economic restitution required and provides substantial legal backing for immediate congressional action.

- 4. Certified UCC 1 Financing Statement Detailing the accounts receivable and funding claims related to HR 40, including references to federal laws governing financial obligations.
- 5. Correspondence and Agreements Outlining engagements with relevant agencies and stakeholders involved in this research.

Pursuant to the applicable legal standards governing document submissions and governmental responses, I request written confirmation of receipt of these materials and an official response from the Committee 7 days from the date of this letter. If additional time is required, kindly provide formal notice of any extensions and the expected date of response.

Additionally, I formally submit the following motions to advance the legislative process for H.R. 40:

- 1. Request for Congressional Hearing: Pursuant to House Rule X and Rule XI, I request a formal hearing by the Subcommittee on the Constitution and Limited Government to examine the findings of the submitted research and its implications for H.R. 40.
- 2. Discharge Petition Submission: If H.R. 40 remains stalled in committee, I request that a discharge petition be initiated under House Rule XV, Clause 2, to bring the bill directly to the floor for a vote.
- 3. Inclusion of H.R. 40 in Must-Pass Legislation: Pursuant to House Rule XXI, I recommend integrating H.R. 40 provisions into forthcoming budget appropriations or national defense funding bills to ensure its passage.
