### To Whom It May Concern:

Pursuant to authority established under **Charter § 1-102 of the City of Atlanta**, **Uniform Commercial Code Article 9**, and the **Restitution Act filings of the State of Loc Nation Global Public Benefit Corporation (SOLN GPBC)**, this Custodial Certificate is issued to confirm the safekeeping and custody of financial instruments assigned to SOLN GPBC.

#### 1. Clerk of Court Governance

On October 18, 2024, the Clerk of the United States District Court for the District of Columbia duly recorded and certified the Transfer/Assignment Agreement (Document 82, Case 1:24-cv-00479-RC). Said filing transferred ownership and title of specified assets and accounts receivable to SOLN GPBC. The



Clerk's stamp and authentication establish the filing as an **official public record** and proof of custody.

#### 2. SOLN GPBC Fiduciary Custody

As transferee and fiduciary trustee, SOLN GPBC, through its governing trust instruments and bylaws, assumes **custody**, **management**, **and control** of the assigned assets. Said assets are held in trust for the benefit of designated beneficiaries, consistent with SOLN GPBC resolutions, the Clement Dynasty Dynasty Trust, and all governing laws cited in the Transfer/Assignment.

#### 3. CPA Audit and GAAP Compliance

Independent Certified Public Accountant reports (see attached) confirm valuation of the **Loc Nation Dollar (LND)** at \$750 per unit, in accordance with **ASC 820 (Fair Value Measurement)** and GAAP principles. Audited financial statements of SOLN GPBC (2023-2024) present fairly, in all material respects, the financial position of the entity and the assets in custody.

#### 4. Custodial Confirmation

By virtue of:

- 1. **The Clerk's official certification** (custodian of record),
- 2. **SOLN GPBC's fiduciary trust authority** (custodian of assets),

and

3. **Independent CPA audit** (valuation and GAAP compliance),

this Custodial Certificate serves as the functional equivalent of a **bank custodial letter**, establishing existence, legal custody, and fair value of the assets for accounting, reporting, and enforcement purposes.

# **Custodial Source of Credit**

The State of Loc Nation GPBC issues Loc Nation Dollar (LND) credits pursuant to:

- Clerk-certified filings (U.S. District Court Case 1:24-cv-00479-RC, Doc. 82; Dekalb Superior Court UCC).
- Independent CPA audit (ASC 820 fair value, \$750 per LND).
- Official Custodial Journal entries (attached).

## 2. Settlement Mechanism

The City does not hold LND. Instead, the City receives USD credits in one of two ways:

# a) Fedwire Settlement

- LND credits are redeemed by SOLN GPBC.
- USD is settled via a Fedwire participant bank directly into the City's treasury account.
- City records USD receipt under GASB 33 donation revenue.



## b) Treasury Offset (31 U.S.C. § 3716 et seq.)

- LND credits are applied against existing City, State, or Federal obligations.
- Liability is reduced by the USD equivalent value.
- City records a liability reduction and offsetting donation revenue.

## 3. Accounting Recognition

Per GASB 33, the City must recognize the USD equivalent of the LND credit as donation revenue when eligibility requirements are met.

- Example (Journal Entry):
  - Debit: Cash (USD received via Fedwire) OR Liability Reduction (offset applied)
- Credit: Contribution Revenue (Donation SOLN GPBC)
