GOVERNING SOLN FRAMEWORK

The Parties agree that participation in the SOLN Network shall be governed by the Constitution, laws, ordinances, regulations, standards, policies, procedures, and operating rules duly established by the State of Loc Nation Global Public Benefit Corporation (SOLN GPBC), as applicable to the participant and the activity undertaken.

Participants voluntarily agree to follow the applicable SOLN framework as a condition of participation in the SOLN Network and LND economic participation system.

Where a US rule conflicts with SOLN mandatory applicable law, the SOLN mandatory law shall control. The parties shall work in good faith to modify the affected SOLN procedure or activity so that the intended purpose of the partnership can continue lawfully.

Participant obligation:

The Participant agrees to review and comply with those SOLN provisions applicable to the Participant's participation, program, transaction, or relationship with SOLN.

4. RESTITUTION FRAMEWORK

SOLN's public FY2024 report identifies a **Restitution Law / SOLN Restitution Act** as part of its governance framework and identifies restitution accounting as having commenced in 2024.

For SOLN purposes, the public glossary defines **Restitution** as corrective restoration of rights, status, property, opportunities, and measurable economic value lost through unlawful acts, including compensation where restoration in kind is impossible.

The Participant acknowledges the Restitution framework as an applicable SOLN policy framework where the Participant voluntarily enters a restitution-related program or transaction.

5. PROTECTIVE LAWS

6. GOVERNMENTAL & DEPARTMENTAL FRAMEWORK

9. LND ECONOMIC PARTICIPATION FRAMEWORK

SOLN identifies LND as “**The Official Black Dollar**” and describes its LND Economic Participation Framework as a system for tracking, coordinating, and reporting economic participation among participating organizations and communities.

The SOLN glossary identifies LND as the **Loc Nation Dollar** and describes it as a parallel unit/reference to USD, including SOLN’s stated reference of **1 LND = \$750 USD**.

Accordingly, participation may include:

ACCEPT → DISTRIBUTE → CIRCULATE → RECORD → RECONCILE → REPORT

Specific transaction rules shall be established through the applicable LND operating standards.

10. SOLN CENTRAL BANK FRAMEWORK

SOLN publicly identifies a **SOLN Central Bank** and describes it as part of its institutional/treasury framework. Its public Treasury materials identify the Constitution/Ladder of Law, SOLN Supreme Tribunal rulings and codes, Restitution Act, UCC filings, applicable federal/state/local law, and consent of the governed as components of the stated legal foundation.

Nothing in this Schedule independently represents that SOLN has received a US governmental banking charter. Fincen and LEI registration received for courtesy notification purposes of operation. Any regulated financial activity remains subject to the law applicable to that activity. SOLN Law is preserved.

For participating institutions, this establishes the intended relationship:

SOLN GOVERNANCE + LAWFUL COOPERATION + INSTITUTIONAL TRUST + MUTUAL ENGAGEMENT.

The Participant agrees to comply with:

C. The Participant's own governing documents; and

D. Mandatory applicable law.

Where the requirements appear inconsistent, the parties shall pause the affected activity and seek clarification or modification rather than assuming that one framework automatically overrides another.

One critical rule: these are SOLN's governing instruments and public records, the referenced UCC filing, court filing, LEI, LCCN, or SOLN-issued document is a legal confirmation of LND operations within our jurisdiction underfunded unrepresented and people historically affected by redlining.

SOLN JURISDICTION & LND OPERATING FRAMEWORK

The parties acknowledge that the SOLN Constitution, laws, codes, executive instruments, policies, economic instruments, public records, and organizational registrations identified in this Schedule constitute the governing framework established by State of Loc Nation Global Public Benefit Corporation (SOLN GPBC), a sovereign polity for activities conducted within the SOLN jurisdiction.

Within that jurisdiction, SOLN recognizes LND — The Official Black Dollar — as an economic instrument established and administered under the SOLN governing framework for participating persons, businesses, institutions, and communities, particularly those historically affected by redlining, underinvestment, economic exclusion, and lack of representation.

The UCC filings, court records, LEI, LCCN, organizational registrations, and SOLN-issued instruments identified in this Schedule constitute documentary records supporting the establishment, identification,

administration, or operation of the SOLN framework and LND activities, according to the legal effect of each respective record.

Nothing in this provision shall be interpreted to alter the legal effect assigned by an external partnering authority to a UCC filing, court record, LEI, LCCN, registration, or other external identifier. The parties' agreement to participate in the SOLN framework constitutes their voluntary recognition of and commitment to the SOLN rules applicable to their participation.

Where activities involve persons, businesses, institutions, or jurisdictions outside the SOLN jurisdiction, the parties shall establish the applicable relationship through the appropriate agreement, recognition mechanism, or other lawful instrument.

PURPOSE OF LND PARTICIPATION

The parties recognize the SOLN LND framework as an economic-development mechanism intended to connect participating businesses, institutions, and communities; facilitate economic circulation; document economic activity; support business-to-business commerce; and address economic conditions associated with historical redlining, underinvestment, exclusion, and underrepresentation. ***SOLN notes are the official paper money used as legal tender in the historical redlining, underinvestment, exclusion, and underrepresentation globally. They serve as a daily medium of exchange for buying goods and paying debts, act as a store of value, and function as the standard SOLN dollar bills (\$1, \$5, \$10, \$20, \$50, and \$100) in circulation upon completion of this agreement.***
