- Understand and be bound by all rules of the NYRCHA as set forth in the Green Program Rules
- Abide by the show conditions set forth at the NYRCHA Shows and events
- Act with honesty and transparency when purchasing horses as well as competing at NYRCHA events
- Ensure the welfare of the horses and cattle I show and treat those horses and cattle humanely, and with dignity and compassion
- Refrain from violating the Non-Pro conditions as set forth in the current NRCHA rulebook and NYRCHA Green Program Rules
- Represent the NYRCHA by refraining from any action that discredits the sport of Reined Cow Horse or the NYRCHA
- Accept the decisions set forth by the NYRCHA Board of Directors
