

**ORDINANCE NO. 2024-O-05**

**ORDINANCE LEVYING AND ASSESSING TAXES OF  
EAST DUNDEE & COUNTRYSIDE FIRE PROTECTION DISTRICT  
KANE AND COOK COUNTIES, ILLINOIS**

**BE IT ORDAINED** by the Board of Trustees of the East Dundee & Countryside Fire Protection District, Kane and Cook Counties, Illinois, as follows:

**Section One:** That the sum of TWO MILLION SEVEN HUNDRED AND NINETY FOUR THOUSAND DOLLARS (\$2,794,000) assessed and levied against all taxable property within the limits of the said East Dundee & Countryside Fire Protection District as the same is assessed and equalized for State and County purposes for the current year, 2024, and are to be applied in liquidation of the appropriations hereto made by Ordinance adopted by the Board of Trustees of the East Dundee & Countryside Fire Protection District at a meeting thereof regularly convened and held on December 17, 2024, and duly published as provided by law and the specific amount hereby levied is set forth under the column entitled Amount to Be Raised by Tax Levy as follows:

**CORPORATE FUND**

AMOUNT TO BE RAISED BY TAX LEVY:

Corporate Fund Levy **\$1,176,500**

The foregoing amount is hereby levied for general corporate purposes.

**AMBULANCE FUND**

Ambulance Fund Levy **\$1,025,000**

The foregoing amount is hereby levied for ambulance expense purposes.

**LIABILITY INSURANCE FUND**

Liability Insurance Fund **\$120,000**

The foregoing amount is hereby levied for liability insurance expense purposes.

**AUDIT FUND**

Audit Fund **\$7,500**

The foregoing amount is hereby levied for audit expense purposes.

**SOCIAL SECURITY FUND**

Social Security Fund **\$50,000**

The foregoing amount is hereby levied for social security expense purposes.

**PENSION FUND**

Pension Fund Capped	<b><u>\$265,000</u></b>
Pension Fund Non Capped	<b><u>\$150,000</u></b>

The foregoing amount is hereby levied for pension expense purposes.


