**ORDINANCE LEVYING AND ASSESSING TAXES OF  
EAST DUNDEE & COUNTRYSIDE FIRE PROTECTION DISTRICT  
KANE AND COOK COUNTIES, ILLINOIS**

**BE IT ORDAINED** by the Board of Trustees of the East Dundee & Countryside Fire Protection District, Kane and Cook Counties, Illinois, as follows:

**Section One:** That the sum of FOUR MILLION SIX HUNDRED AND SIXTEEN THOUSAND ONE HUNDRED AND FIFTY TWO (\$4,616,152.00) DOLLARS assessed and levied against all taxable property within the limits of the said East Dundee & Countryside Fire Protection District as the same is assessed and equalized for State and County purposes for the current year, 2020, and are to be applied in liquidation of the appropriations hereto made by Ordinance adopted by the Board of Trustees of the East Dundee & Countryside Fire Protection District at a meeting thereof regularly convened and held on December 15, 2020, and duly published as provided by law and the specific amount hereby levied is set forth under the column entitled Amount to Be Raised by Tax Levy as follows:
