Chapter 6 Bylaws

Notice: The Chapter 6 ad-hoc Bylaws Committee met and by unanimous motion approved asking the Chapter membership to consider the following revision to Article III, Section 6 of the bylaws:

If permitted by the President (or Vice President in the President's absence) in such person's sole discretion, Chapter members may participate in a meeting, other than the annual meeting, by telephone or electronic meeting where all voting members are able to have full 2-way real-time communications and the Secretary is able to take minutes of such participation (collectively, "Telephone Conference"). There is no requirement that any meetings be held by Telephone Conference.

This bylaws revision will be considered and voted on at our next general meeting on April 13th, 2021 at 6:00pm by Zoom video conference. A minimum of 20 Chapter 6 members are required to enact a bylaws revision, we appreciate all who can join the Zoom meeting to help us open up our annual meeting to allow all to participate.

This proposed revision has been reviewed by the IRWA General Counsel and IRWA International Executive Committee Designee for reviewing Chapter Bylaws.
