The Carina Nebula

They call this scene the Cosmic Cliffs. It's the edge of a gigantic, gaseous cavity within another dusty, star-forming nebula, known as Carina. The cavity has been sculpted by the intense ultraviolet radiation and winds from hot, young stars just out of shot. From one side of this image to the other is a distance of roughly 15 light years. One light year is equal to about 5.88 trillion miles so this picture is 88.2 trillion miles across.


