

Privacy Policy for Zero Ducks Given

Thank you for playing **Zero Ducks Given**, developed by **Fischerboyy Studios**. This Privacy Policy explains what user data is collected, how it is used, stored, and how you can request its deletion. This applies to **all users globally** for all versions of the game distributed through the Meta Quest Store.

1. Information We Collect

A. User-Provided and Platform Data

Our game collects the following:

- **USER_ID:** A unique platform-assigned identifier used to identify you in multiplayer sessions.
- **USER_PROFILE:** Your display name, avatar, and other profile data provided by the platform.
- **IAP Data:** Information about in-app purchase activity, such as items purchased, purchase status, and transaction history.

B. Automatically Collected Data

- Device information (headset model, operating system, performance metrics)
- Gameplay data (session time, in-game actions)
- Crash reports and diagnostics

C. Data We Do NOT Collect

- Biometric or health data

- Geolocation
- Financial information beyond in-app purchase records

2. How We Use Your Data

We use the collected data **only** to:

- Enable multiplayer functionality
- Sync player progress and state across devices
- Track and manage in-app purchases
- Improve game stability and performance
- Detect and prevent cheating or abuse

We do **not** sell, rent, or share your data with advertisers.

3. Data Storage and Security

- **Storage:** All user data, including IAP data, is stored securely on Meta's and PhotonVR's servers.
- **Retention:** Data is retained only as long as necessary for gameplay, multiplayer functionality, and purchase management.
- **Protection:** We follow reasonable technical and administrative measures to protect your data from unauthorized access or disclosure.

4. User Rights and Deletion Requests (Available Globally)

All users, **regardless of geographic location**, may request access to their data or request that their data, including IAP records, be deleted. To do this:

2. Include your **USER_ID** or platform display name so we can identify your data.

We will respond and complete your deletion request **within 30 days** for all users worldwide.

5. Third-Party Services

- **Photon (Exit Games):** Multiplayer syncing; stores USER_ID, profile info, and in-game state.
- **Unity:** Device info, crash logs, minimal analytics.
- **Meta (Oculus):** Platform may process USER_ID, profile info, and IAP data for multiplayer and in-app purchase management.

6. Children's Privacy

We do not knowingly collect personal information from children.
